**RE: Notice of Claim for Estate of Douglas Kantor  
Date of Incident: June 20, 2021**

Dear Sir or Madam:

Pursuant to the laws of the State of Texas and the City of Austin, I hereby provide you written notice of claims that will be brought against you on behalf of the Estate of Douglas Kantor. Specifically, I advise you of the following:

**DESCRIPTION OF INCIDENT**

On June 12, 2021, Douglas Kantor was the innocent victim of a mass shooting incident which took place near the Mooseknuckle Pub at 406 E. 6th Street in Austin. The publicly available information proves that this incident began when two rival gangs of teenagers from Killeen, Texas deliberately drove to 6th street in Austin to engage in a fight. After a long period of public argument De'Ondre White pulled out a gun and fired, hitting, among others, Douglas who was an innocent bystander.

The incident was a foreseeable result of the Mayor and the City council of Austin's intentional and solely politically motivated decision to defund the police and/or to dissolve the Austin Police Department's anti-gang unit.

**TIME AND PLACE OF INCIDENT:**

This incident took place near the Mooseknuckle Pub at 406 E. 6<sup>th</sup> Street in Austin on June 12, 2021 in the early morning hours.

**DAMAGE OR INJURY CLAIMED**

After more than 24 hours of pain and suffering, Doug succumbed to his injuries and passed away at around 12:00pm on June 13, 2021. Douglas was only 25 years old at the time of his death. Douglas is survived by, inter alia, his mother Julia, his brother Nicholas, and his uncle Lawrence, who have all lost out on the love, care, maintenance, companionship, comfort, services, support, advice, and counsel that he would have provided for the remaining years of his life.

As this incident only happened on June 12, 2021 and is the subject of an ongoing criminal investigation and prosecution, supporting documents are limited at this time. Such documents will be provided upon request as soon as they are in our possession.
