**FIRST AMENDED COMPLAINT**

COMES NOW, the Georgia Government Transparency and Campaign Finance Commission (hereinafter "Commission") which amends its Complaint (hereinafter "Complaint") against New Georgia Project, Inc. and New Georgia Project Action Fund, Inc. (hereinafter "Respondent NGP" and "Respondent NGP(AF)" respectively, and "Respondents" collectively) as follows:

1.

The Commission hereby incorporates and reasserts paragraphs 1 through 17 of its original Complaint filed on September 20, 2019 as if fully restated herein.

2.

By substituting the following paragraphs following paragraph 17 for paragraphs 18 through 26, to wit:

"18.

Respondents failed to file any required disclosure reports containing the contributions

or expenditures associated with their advocacy of Democratic candidates participating in the 2018 primary, general, and run-off elections; therefore, Respondents violated O.C.G.A. § 21-5-34(f)(1) nine (9) times. See Exhibit C.

19.

Reports filed by independent committees must list the name of any contributor, their mailing address, their employer, and the amount and date of the contribution made to the independent committee. *See generally* O.C.G.A. § 21-5-34(f)(2). Disclosing these contributions allows the public access to know the identities of those funding a campaign and furthers the democratic process.

20.

In this matter, Respondent violated O.C.G.A. § 21-5-34(f)(2)(A) when they failed to disclose approximately \$4,216,783.07 in contributions, to wit;

**I. Respondents' Failure to Register and Report as a Ballot Committee**

23.

A ballot committee is a non-candidate campaign committee that accepts contributions or makes expenditures designed to bring about the approval or rejection of a proposed constitutional amendment, a state-wide referendum, or a proposed question which is to appear on the ballot in any state, county, or municipal election. O.C.G.A. § 21-5-2(2).

24.

O.C.G.A. § 21-5-34(a)(2) requires a ballot committee accepting contributions or making expenditures designed to bring about the approval or rejection of a proposed question which is to appear on the ballot in a county election to register with the election superintendent in the county of election.

25.

Once a ballot committee supporting or opposing a ballot question appearing on a county ballot has received contributions totaling more than \$500 or has made expenditures totaling more than \$500, the ballot committee is required to file campaign disclosure reports with the county election superintendent in accordance with the filing schedule contained in O.C.G.A. § 21-5-34(a)(2)(B).

26.

O.C.G.A. § 21-5-34(a)(2)(B) requires a ballot committee to file campaign disclosure reports, "15 days prior to the date of the election; and a final report shall be filed prior to December 31 of the election year." O.C.G.A. § 21-5-34 (2)(B).

27.

A proposed question relating to the expansion of transit appeared on the Gwinnett



County ballot during the March 19, 2019 special election.

28.

Respondents accepted contributions and made expenditures exceeding \$500 that were designed to bring about the approval of the ballot question relating to transit expansion on the March 19, 2019 Gwinnett County Ballot. See Exhibit D.

29.

Respondents never registered as a ballot committee in 2018 or 2019; therefore, Respondents violated O.C.G.A. § 21-5-34(a)(2) when they failed to register with the Gwinnett County election superintendent as a ballot committee prior to the acceptance of contributions and making of expenditures.

30.

Because Respondents exceeded \$500 in contributions and/or expenditures, Respondents were required to file a campaign disclosure report 15 days prior to the election held on March 19, 2019. Respondents failed to file a campaign contribution disclosure report on March 14, 2019 in violation of O.C.G.A. § 21-5-34(a)(2).

31.

Respondents failed to disclose approximately \$646,422.89 in contributions in violation of O.C.G.A. 21-5-34(a)(2), to wit;

WHEREFORE, Commission staff pray as follows:

- a) That process issue and Respondents be served with a copy of the Complaint and First Amended Complaint;

In her khaki pants and bright yellow New Georgia Project T-shirt, Michelle Sanchez walks the streets of this aging Lawrenceville-area neighborhood on a foggy Friday trying to find very specific voters — Latino folks, black folks, youngish folks, residents she says would likely vote in favor of [Gwinnett County's MARTA referendum](#) on March 19.

She's consults the app on her phone, seeking the address of the voter she's trying to reach. She knocks on several doors. Each time, no dice.

Then, finally, House Number 10: a bright pink number with white lattice hung from the porch rails. Sanchez twice completes her customary knock (shave-and-a-haircut, two-bits) and no one answers. She turns around to leave and makes it down most of the driveway — then a white Kia SUV pulls in. Bingo.

Sanchez and her colleagues at the New Georgia Project Action Fund — an advocacy arm of the group formed years ago by rising Democratic star Stacey Abrams — represent just one of several organizations advocating for Gwinnett's historic MARTA referendum. Their politics, and their specific approaches, vary. But their goal is largely the same: identify voters that will likely support transit and get them to the polls. Their combined efforts represent a sizable — and perhaps surprising — show of force in support of the vote that, one way or another, will shape the future of Gwinnett and the entire metro Atlanta region. And with an opposition effort that currently consists primarily of a few Facebook groups, the efficacy of the pro-transit turnout efforts could very well swing the election.

### **'In an intentional way'**

The referendum's passage would make the suburban county of nearly a million people a member of MARTA and commit residents and visitors to paying a new 1 percent sales tax until 2057. The tax revenues would cover the cost of new transit projects like a rail extension from Doraville to Norcross, bus rapid transit and greatly expanded local bus service.

While Gwinnett has changed demographically and politically since its last vote on MARTA in 1990 — Abrams herself took the long-conservative county by more than 14 points in November — the issue being placed on a standalone ballot has put pro-transit forces in a pinch. There are still plenty of older, more conservative voters in Gwinnett, and they're the ones who most reliably vote in special elections — and the ones most likely to vote no.

**"What's very clear to me," Fred Hicks, the New Georgia Project Action Fund's campaign manager, "is that this whole thing hinges on who comes out to vote."**

Hicks said his group has had paid canvassers like Sanchez wandering Gwinnett since before the Super Bowl. It hopes to hit 100,000 doors by Election Day.

They're not alone in the push.

There's also the "Yes to MARTA" committee, which is [being led by members of the Georgia Sierra Club](#). They've been canvassing and hosting events to try and touch base with 60,000 folks they've identified as environmentally-conscious voters. The Georgia Association of Latino Elected Officials has joined the effort recently too, with the goal of calling and visiting as many Latino voters as possible. They are sending mailers to all 33,000 or so Latino households in the county.

The Democratic Party of Georgia [recently pledged to go "all in" on the referendum](#), lending resources and other support to aid local efforts. Gwinnett's arm of the Democratic Party is canvassing itself and joining some of the efforts led by other groups, [including texting efforts led by New Georgia](#).

There's also [the "Go Gwinnett" committee](#), spearheaded by local business people and Rotarians. That group has kept its strategy close to the vest but canvassing and phone-banking and social media ads are all on the table. "I want to stress, we're trying to do this in an intentional way," Paige Havens, a Go Gwinnett spokeswoman, said. "We are working a great deal on voter identification and making sure that those people who understand and appreciate the true benefit of transit are out for the vote."

There is an education component to all of the advocacy groups' efforts. It's clear that many Gwinnett residents, even if they're aware of the referendum, don't know much about the county's pending contract with MARTA or that the plan involves a lot more than just a four- or five-mile passenger rail extension from Doraville to Norcross.

But the goal is not really to flip those opposed to transit. It's to get those already in favor to the polls.

"The thing is, we know that transportation here in Gwinnett is popular," said Bianca Keaton, the new chair of the Gwinnett County Democratic Party. "It would have passed if it were scheduled during a regular election, when they knew people would come out."

### **'Being able to get around'**

As it turns out, the woman in the white Kia, the one in the driveway in Lawrenceville, is well aware of the referendum. She tells Sanchez, the 33-year-old canvasser from the New Georgia Project, that she plans to vote yes. And that she'll tell her family members to do so, too.

"I think it would help when it comes to more jobs and people being able to get around," Kimberly Coleman, 47, says. "And maybe reduce the congestion of traffic too."

Like Coleman, advocates of Gwinnett's transit push believe expanded service would help [relieve congestion](#), improve job opportunities for residents, drive economic development and help reduce the negative impact of the 500,000 or so new residents expected to move to Gwinnett in the coming decades.

Some detractors say that the \$5.5 billion plan that would guide new transit projects if the referendum passes is simultaneously too expensive and lacking in [coverage for the entire county](#). Others simply don't want to pay a new tax or are opposed to public transportation more generally.

Count Sanchez among the former group. After speaking with Coleman, she happily gets back into her own car and drives to her next destination — a row of townhomes a few streets over.

She has slightly better luck than she did with Coleman's neighbors. She gets a couple folks in a row, then a bonus woman unloading groceries at a house that's not even on her list.

"It's really nice when people's faces light up at information they didn't know that is valuable to them, and that they can act on," Sanchez said. "And they can actually feel like they can do something."

**What it means:** A yes vote would be a vote in support of ratifying Gwinnett's pending transit service contract with MARTA, allowing it to take over Gwinnett's current transit services and greatly expand them — including a possible rail extension into the Norcross area and an extensive bus system with diverse options.

A yes vote would also trigger a new 1 percent sales tax to pay for such projects. Purchases in Gwinnett are currently subject to 6 percent sales tax. The new countywide sales tax would remain in effect until 2057 and garner billions of dollars. Collected funds would be remitted to Gwinnett County, which would then write checks to MARTA for projects and operations.

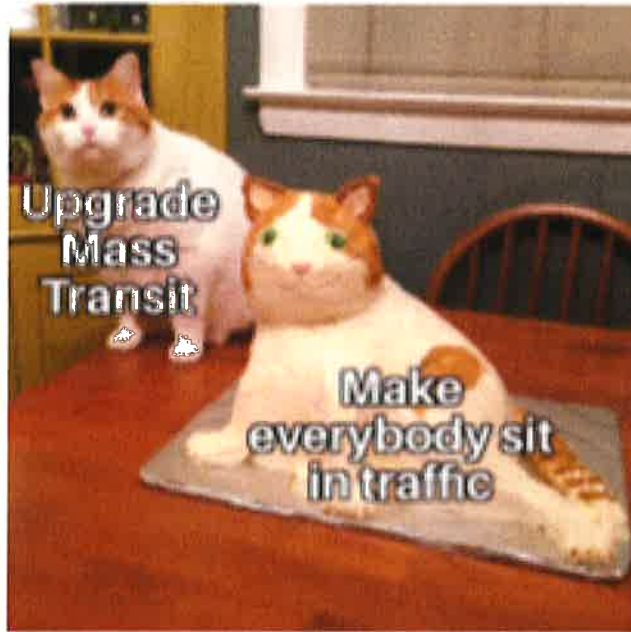

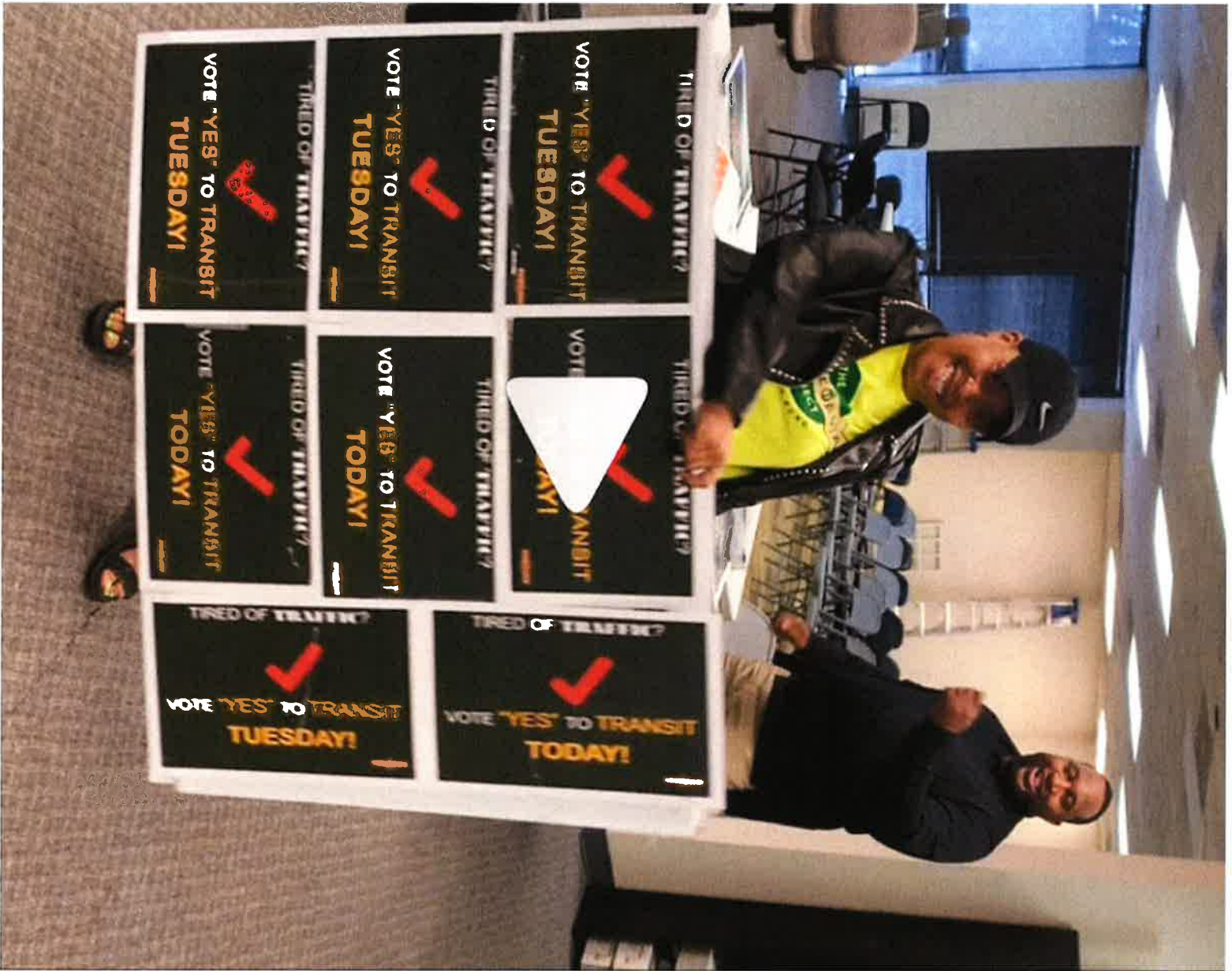

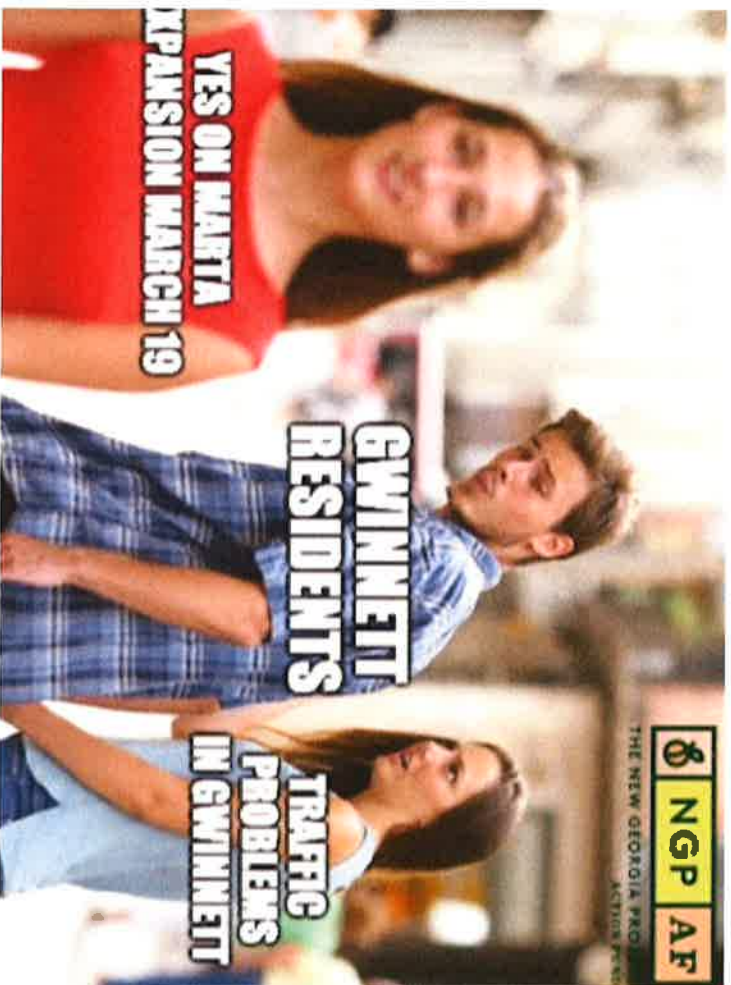

Dear Mr. Emadi and Mr. Cusack:

We write as counsel to New Georgia Project, Inc. (“NGP”) and New Georgia Project Action Fund (“NGPAF”), (collectively, “Respondents”) in response to the September 20, 2019 Complaint initiated by the Georgia Government Transparency and Campaign Finance Commission (the “Commission”). For the reasons fully articulated below, we respectfully submit that the Commission should immediately dismiss the Complaint.

The Complaint alleges that Respondents violated the Georgia Government Transparency and Campaign Finance Act (the “Act”) by accepting contributions and making expenditures that advocated (1) the election of certain candidates during the 2018 statewide elections, and (2) support for a ballot question which appeared on the Gwinnett County ballot in 2019, and by failing to register and report as independent committees and ballot question committees. But these allegations are without merit.<sup>1</sup> The definitions of “independent committee” and “campaign committee” under the Act are unconstitutional because they contain no limitation regarding the purpose of such committees. The First Amendment requires that Georgia subject only those groups that are under the control of a candidate or have the “major purpose” of nominating or electing candidates to committee registration and reporting. Otherwise such restrictions impermissibly chill political speech.

The Act's registration and reporting requirements, which require groups to register and report without regard to their purpose, are unconstitutional and unenforceable. Because the Complaint alleges only that Respondents failed to comply with these unconstitutional registration and reporting requirements, and because Respondents would not be required to register under a constitutional version of the law, it should be dismissed.

Moreover, even if Georgia's statutory definitions of "independent committee" or "campaign committee" were constitutional, which they are not, NGPAF still would not have met the definition of "independent committee" for the canvassing work it was paid to engage in by registered independent committees in Georgia for the 2018 statewide election. *See* Compl. ¶ 15. NGPAF was paid as a canvassing vendor for commercial purposes. Such activity does not trigger registration or reporting under the Act. Accordingly, for the reasons detailed herein, we request that the Commission promptly dismiss the Complaint.

### BACKGROUND

NGP is a nonpartisan organization that seeks to register and civically engage Georgians. Its purpose is to register "all eligible, unregistered citizens of color in Georgia" to vote.<sup>2</sup> NGP is organized under section 501(c)(3) of the Internal Revenue Code. On February 21, 2019, the Internal Revenue Service granted NGP status as a public charity.

NGPAF is a social welfare group organized under section 501(c)(4) of the Internal Revenue Code. Its primary purpose is to "increase the civic participation of underrepresented and underserved communities of color."<sup>3</sup> As a section 501(c)(4) organization, "electoral political activity" is not its primary purpose. In 2018, PowerPAC Georgia and Working Families Party (both registered independent committees in Georgia) hired NGPAF as a vendor to engage in canvassing on their behalf in support of statewide candidates for office in 2018. NGPAF was hired as a vendor to perform certain delineated canvassing services in service of the committees.

For example, PowerPAC Georgia and NGPAF entered into a written fee for service agreement<sup>4</sup> stating that NGPAF would act as an independent contractor with respect to the services it provided and "have no authority whatsoever to incur any liability or expense on behalf of the Committee." Consulting Agreement at § 8. All advertising copy, writings and materials, and all other works, the Agreement continued, "produced by [NGPAF pursuant to the agreement] will become and remain the exclusive property of [PowerPAC Georgia]." *Id.* § 7.2. Because the canvassing expenditures were made by PowerPAC Georgia, and the canvassing services were performed on

behalf of that committee, the canvassing scripts carried by NGPAF canvassers contained a “Paid for by PowerPAC Georgia” disclaimer in accordance with the Act.

## LEGAL DISCUSSION

### **I. The Act’s Definitions of “Independent Committee” and “Campaign Committee” are Unconstitutional and Unenforceable.**

The Complaint erroneously alleges that Respondents failed to register as “independent committees” with respect to their alleged activity in support of statewide candidates in 2018, and as “ballot committees”<sup>5</sup> with respect to their alleged support of a local ballot measure in 2019. Compl. at ¶¶ 16-17, 24-25. However, the definitions of “independent committee” and “campaign committee” under the Act are unconstitutional because they contain no limitation regarding the purpose of such committees. As discussed in detail below, the First Amendment requires that Georgia subject only those groups who are under the control of a candidate or have the “major purpose” of nominating or electing candidates to political committee registration and reporting burdens. As such, the Georgia state laws requiring “independent committees” and “campaign committees” (as those terms are currently defined) are unenforceable. Moreover, the Complaint against Respondents—which alleges only that they failed to comply with these unconstitutional registration and reporting requirements—must be dismissed.

#### **A. The Act’s Definitions of “Campaign Committee” and “Independent Committee” Lack a Purpose Requirement.**

Under the Act, a “campaign committee” means “the candidate, person, or committee which accepts contributions or makes expenditures designed to bring about the nomination or election of an individual to any elected office.” Ga. Code Ann. § 21-5-3(2). “Campaign committee” also includes “any person or any committee which accepts contributions or makes expenditures designed to bring about the approval or rejection by the voters of any proposed constitutional amendment, a state-wide referendum, or a proposed question which is to appear on the ballot in this state or in a county or a municipal election in this state.” *Id.* Similarly, an “independent committee” includes any corporation or other group of persons “which receives donations during a calendar year from persons who are members or supporters of the committee and which expends such funds either for the purpose of affecting the outcome of an election for any elected office or to advocate the election or defeat of any particular candidate.” *Id.* § 21-5-3(15).

Thus, pursuant to the Act, and as alleged by the Complaint, *any* group of persons that accepts contributions or makes expenditures for the purpose of affecting the outcome of an election, or advocates the election or defeat of any candidate—regardless of whether that group’s major purpose is electoral political activity—is subject to Georgia’s extensive and burdensome registration and reporting requirements. *Id.* § 21-5-34(f)(1).

In particular, the Act requires groups that meet the definition of “independent committee” to register prior to making independent expenditures or accepting contributions. *Id.* § 21-5-34(e). After registration, independent committees are required to comply with extensive reporting obligations, including disclosing contributions received, expenditures made on reports due two months prior to the election, one month prior to the election, two weeks prior to the election, and a supplemental disclosure report after the date of the election. *Id.* § 21-5-34(f)(1); *see also* Compl. ¶ 17. Groups that meet the definition of “campaign committee” by accepting contributions or making expenditures related to supporting or opposing a proposed question to appear on the ballot are required to register and, if they receive contributions or make expenditures totaling more than \$500.00, must report with the Commission. *Id.* § 21-5-34(a)(2)(A). After registration, such campaign committees must file a report 15 days prior to an election and a second report prior to December 31 of the election year. *Id.* § 21-5-34(a)(2)(B).

**B. Political Committee Registration and Reporting Requirements that Do Not Contain a Purpose Limitation are Unconstitutional.**

In *Buckley v. Valeo*, the Supreme Court explained that “compelled disclosure, in itself, can seriously infringe on privacy of association and belief guaranteed by the First Amendment” and must therefore survive “exacting scrutiny.” *Buckley v. Valeo*, 424 U.S. 1, 64 (1976) (internal citation omitted). Under *Buckley*, “significant encroachments on First Amendment rights of the sort that compelled disclosure imposes cannot be justified by a mere showing of some legitimate governmental interest. Since *NAACP v. Alabama*, we have required that the subordinating interests of the State must survive ‘exacting scrutiny.’” *Id.* This requires a “substantial relation” between the disclosure requirement and a ‘sufficiently important’ governmental interest. *Citizens United v. Federal Election Commission*, 558 U.S. 310, 366-67 (2010). Applying this standard, the Court in *Buckley* held that under federal law, the government may mandate registration of groups engaged in political activity only where such organizations are “under the control of a candidate or the major purpose of which is the nomination or election of a candidate.” *Buckley*, 424 U.S. at 79. Otherwise, requiring registration of groups without the requisite major purpose risks imposing a burden on speech so impermissibly overbroad and vague that it threatens the protection of core First Amendment freedoms. *See id.* at 79-80.

Courts that have reviewed challenges to state campaign finance committee registration and reporting requirements have consistently held that state laws that require registration and reporting

but lack a “purpose test” violate the First Amendment. The Fourth Circuit Court of Appeals, for example, struck down North Carolina’s political committee definition as overbroad, vague, and facially unconstitutional because it required the registration of groups with “a” rather than “the” major purpose of supporting or opposing the nomination or election of candidates. As that court noted:

If organizations were regulable merely for having the support or opposition of a candidate as “a major purpose,” political committee burdens could fall on organizations primarily engaged in speech on political issues unrelated to a particular candidate. This would not only contravene both the spirit and the letter of *Buckley’s* “unambiguously campaign related” test, but it would also subject a large quantity of ordinary political speech to regulation. *N. Carolina Right to Life, Inc. v. Leake*, 525 F.3d 274, 287–88 (4th Cir. 2008).

The court went on to state that campaign finance regulations have become “an area in which speakers are now increasingly forced to navigate a maze of rules, sub-rules, and cross-references in order to do nothing more than project a basic political message.” *Id.* at 296. To protect constitutionally guaranteed freedoms among this maze of rules, regulators must, at a very minimum, adhere to basic First Amendment safeguards in enacting and applying registration and reporting requirements.

Similarly, while noting that *Buckley’s* major purpose test “sets the lower bounds for when regulation as a political committee is constitutionally permissible,” the Tenth Circuit held that a New Mexico law that required groups spending \$500 on election-related expenses to register as committees was unconstitutional because a spending trigger does not satisfy the major purpose test. *New Mexico Youth Organized v. Herrera*, 611 F.3d 669, 677-79 (10th Cir. 2010); *see also Colorado Right to Life Comm., Inc. v. Coffman*, 498 F.3d 1137, 1154 (10th Cir. 2007) (noting that a monetary trigger, standing alone, cannot serve as a proxy for the major purpose test). The Eighth Circuit has held that “the major purpose” of an organization is an “important consideration” in determining the extent of permissible regulation. *Iowa Right to Life Comm., Inc. v. Tooker*, 717 F.3d 576, 592 (8th Cir. 2013).

While it does not appear that the Eleventh Circuit has directly addressed this issue, in upholding a challenge to a set of disclosure laws in Florida, the court implicitly recognized that a major purpose test should be applied to political committee registration requirements, specifically noting that the law upheld by the court did not have a “problem with a lack of a ‘major purpose’ test” because the challenged law did not “impose[ ] . . . requirements on *all* associations, regardless of the association’s purpose.” *Worley v. Fla. Sec’y of State*, 717 F.3d 1238, 1252 n.7 (11th Cir. 2013). In particular, in Florida, for all elections, including ballot issue elections, “[c]orporations regulated

by chapter 607 or chapter 617 or other business entities formed for purposes other than to support or opposes issues or candidates are, in fact not considered political committees.” *Id.*<sup>6</sup>

Under the well-settled principles of constitutional law discussed above, the Act’s registration and reporting requirements for groups that lack the major purpose of electoral activity violate the First Amendment of the United States Constitution because they chill political speech. *See Buckley v. Valeo*, 424 U.S. at 64. The Act far exceeds the lower bounds established under *Buckley* because it includes *no* test at all for major purpose, and therefore infringes on core First Amendment rights to speech and association. The Act’s committee registration and reporting requirements are therefore unconstitutional and unenforceable.

Based on this unconstitutional statute, the Complaint makes sweeping allegations that “[b]ecause Respondents accepted contributions and made expenditures to advocate for the election of candidates” and “[b]ecause Respondents exceeded \$500 in contributions and/or expenditures,” they were required to register and file disclosure reports. Compl. at ¶¶ 17, 24. But the Complaint does not allege that Respondents had the requisite major purpose to be required to register as committees under the constitutional protections recognized by the Supreme Court. Because the Complaint alleges only that Respondents violated provisions of the Act which are unconstitutional, and because Respondents would not be required to register under a constitutional version of the Act, it should be dismissed.

## **II. NGPAF Acted as a Paid Canvassing Vendor in 2018 and Did Not Trigger Independent Committee Status**

In 2018, NGPAF was paid as a commercial vendor by two entities—PowerPAC Georgia and Working Families Party GA—to engage in canvassing in support of various candidates who appeared on the 2018 statewide ballot. The Act does not require entities such as NGPAF, which was acting as a commercial vendor, to register as an independent committee.

### **A. Applicable Law**

As discussed above, the Act defines an “independent committee” as “any committee, club, association, partnership, corporation, labor union, or other group of persons, other than a campaign committee, political party or political action committee, which receives donations during a calendar year from persons who are members or supporters of the committee and which expends such funds either for the purpose of affecting the outcome of an election for any elected office or

to advocate the election or defeat of any particular candidate.” Ga. Code Ann. § 21-5-3(15) (emphasis added).

Moreover, the Act requires “[a]ny independent committee which accepts contributions or makes expenditures for the purpose of affecting the outcome of an election or advocates the election or defeat of any candidate shall register with the [Commission] prior to accepting contributions or making expenditures. . .” *Id.* § 21-5-34(f)(1). “Contribution” is defined by the Act to mean “anything of value conveyed or transferred for the purpose of influencing the nomination for election or election of any person for office, bringing about the recall of a public officer holding elective office or opposing the recall of a public officer holding elective office, or the influencing of voter approval or rejection of a proposed constitutional amendment, a state-wide referendum, or a proposed question which is to appear on the ballot . . .” *Id.* § 21-5-3(7). “Expenditure” is defined by the Act to mean “anything of value made for the purpose of influencing the nomination for election or election of any person, bringing about the recall of a public officer holding elective office or opposing the recall of a public officer holding elective office, or the influencing of voter approval or rejection of a proposed constitutional amendment, a state-wide referendum, or a proposed question which is to appear on the ballot . . .” *Id.* § 21-5-3(12).

#### **B. NGPAF Did Not Meet the Definition of “Independent Committee.”**

NGPAF did not qualify as an independent committee because it did not “receive *donations* from persons who [were] *members or supporters*” of NGPAF and then *expend funds itself* to engage in canvassing in support of statewide candidates. *See id.* § 21-5-3(15) (emphasis added). It also did not receive “contributions” or make “expenditures,” because those terms both provide that to qualify, the funds must be “for the purpose of influencing” the nomination or election of a candidate. Instead, in 2018, two independent committees already registered in Georgia (PowerPAC Georgia and Working Families Party) paid NGPAF a fee in exchange for the canvassing services it provided. Those committees did not *make donations* to NGPAF; they paid fees for services provided. The committees were not *members or supporters* of NGPAF; NGPAF acted as a commercial vendor to them. And finally, NGPAF did not *expend funds for the purpose of affecting the outcome of an election or to advocate the election or defeat of any particular candidate*. It engaged in canvassing activity that it was paid to do for a commercial purpose on behalf of other committees. NGPAF did not receive “contributions” or make “expenditures” for the purpose of supporting the nomination or election of candidates; it received fees and spent the fees received for a commercial purpose—it was hired and paid fees pursuant to consulting agreements to engage in advocacy activities on behalf of two registered independent committees in Georgia.

As the consulting agreements between NGPAF and PowerPAC Georgia demonstrate, the canvassing activity that NGPAF executed on behalf of PowerPAC Georgia, for example, was not



NGPAF activity; it was activity that was paid for and controlled by PowerPAC Georgia. NGPAF accepted payments from those PowerPAC Georgia and Working Families Party Georgia to deliver *those committees'* advocacy for candidates.<sup>7</sup> In this respect, NGPAF's services were similar to those of consultants, such as media consultants, mail vendors, digital ad developers, and content hosts that facilitate communications on behalf of a client. These types of vendors are not required to register and report as independent committees under the Act.

### CONCLUSION

The Complaint alleges only that Respondents failed to comply with unconstitutional registration and reporting requirements that are unenforceable. Moreover, even applying the unconstitutional definitions, the commercial activities that NGPAF engaged in during the 2018 election cycle did not meet the definition of "independent committee." Accordingly, Respondents were not required to register and report under the Act. Because the Complaint's allegations are meritless, we respectfully request an immediate dismissal of this matter.

## CONSULTING AGREEMENT

This Agreement, made and entered into as of the 8<sup>th</sup> of October 2018 by and between PowerPAC Georgia (“Committee”) and New Georgia Project Action Fund (“Vendor”), witnesseth:

In consideration of the mutual covenants contained in this Agreement, it is agreed as follows:

### 1. Services to be Performed

- 1.1 During the term of this Agreement, Vendor agrees to perform the following Services for the Committee:

## STATEMENT OF WORK

Nse Ufot, Executive Director of the New Georgia Project Action Fund will manage a voter contact program aimed to contact Black voters to vote for Stacey Abrams during the May 2018 Gubernatorial Primary Election.

1. Deploy volunteers and paid canvassers to contact a universe of 550,822 infrequent voters (301,874 households) through a three pass canvass, incorporating Abram’s messaging and plan to vote language, in order to identify 200,000 and turn out 100,000 Black voters supporting Stacey Abrams for Governor in the following areas: (SOUTH METRO ATLANTA – Clayton, Dekalb, Douglas, Fayette, Henry, Rockdale; NORTH METRO ATLANTA – Gwinnett, Cobb; Bobb, Muscogee, Dougherty and Richmond counties, and; the Black Belt (HD 151).
2. Door-to-door canvassing will be performed multiple times a week at a rate that ensures weekly goals are met. Canvassers will consist of both volunteers and paid staff and will work from 11 am to 8 pm on weeknights and weekends, and 6am to 7pm on Election Day, Tuesday November 6, 2018
3. Recruit, train and manage canvassers and canvass operations.
4. Manage distribution of any canvass materials provided by PowerPAC Georgia.
5. Manage VAN products and inputs.
6. Interact with other consultants assigned to the project to coordinate message content and timing.
7. File a weekly written report with Marvin Randolph each Friday by 9 pm.

8. Update Google Doc with daily cumulative tally of canvass results, including but not limited to Completed IDs and Voters IDed for Abrams
9. File a final written report with Marvin Randolph by November 13, 2018.
10. Help with the preparation of all reports to the programs funders.
11. Be available to PowerPAC Georgia Campaign Manager Marvin Randolph for telephone conference calls.

## **DELIVERABLES**

Deliverables include:

1. Final Budget
2. Weekly written reports
3. Final Data exported from the VAN
4. Final Scripts
5. Training agendas, curriculums, videos, role plays, notes from debriefs
6. Collateral Material or canvass leave behinds from the program
7. Final Report

## **FINAL REPORT**

Produce a post election report that includes the following:

1. Demographics
2. Historical Turnout Rates
3. Total Turnout Rates (number of votes and turnout rates)
4. Vote Share
5. Turnout Rates by (First Time Registrants, Infrequent Voters, and Super Voters)
6. Political Importance of the race/Context
7. Program Description (Door Knocks, Shifts, Geography)
8. Program Impact
9. Election Results
10. Lessons Learned

## **TIMELINE**

The term of this contract is October 4, 2018 to December 31, 2018.

## **PAYMENT SCHEDULE**

**Payment Terms.** Contractor shall issue an invoice for the total contract amount to Powerpac Georgia. Powepac Georgia will issue a payment of \$500,000 upon receipt of invoice and signed contract.

- 1.2 In performing the Services, Vendor will comply with all known federal, state, and local laws, ordinances, rules, regulations, orders, licenses, permits and other governmental requirements applicable to the Services.

### **2. Compensation and Expenses**

- 2.1. As consideration for all of the services to be provided under this Agreement, the Committee will pay Vendor based on the amount of time Vendor employees and consultants spend on the Services, payable within thirty days of monthly invoice by the Vendor.
- 2.2. All costs will be paid directly by the Committee. Vendor will not incur any cost on behalf of Committee, besides staff time and internal resources, without the approval of the Committee before incurring such cost.
- 2.3. All invoices to the Committee will be complete, detailed and in writing.
- 2.4. Vendor's relationship with Committee will be that of an independent contractor and nothing in this Agreement should be construed to create a partnership, joint venture, or employer-employee relationship. Vendor is not the agent of Committee and is not authorized to make any representation, contract, or commitment on behalf of Committee. Because Vendor is an independent contractor, Committee will not withhold or make payments for social security or any federal, state or local taxes; make unemployment insurance or disability insurance contributions; or obtain worker's compensation insurance on Vendor's behalf.

### **3. Assistance with Government Inquiry**

- a. Vendor will provide, in a timely manner, to the Committee, at no additional charge, all documents, services, and personnel necessary to assist the Committee in connection with any audit, inquiry or investigation of the Committee by the Federal Election Commission, the Internal Revenue Service, state election commissions, or local election monitoring commissions.

- b. Such obligations of the Vendor will survive the termination of this Agreement.

4. **Indemnification and Hold Harmless**

- a. Vendor agrees to indemnify and hold the Committee harmless from and against any and all damages, fines, costs, liabilities, causes of action, suits, judgments and expenses (including reasonable attorney's fees, disbursements, and actual costs), losses and court costs suffered by the Committee, directly or indirectly, solely to the extent based on or arising out of Vendor's gross negligence, or knowing violation of known applicable federal, state, or local laws.
- b. Committee agrees to indemnify and hold Vendor harmless from and against any and all damages, fines, costs, liabilities, causes of action, suits, judgments and expenses (including reasonable attorney's fees, disbursements and actual costs), losses and court costs suffered by the Vendor, including but not limited to any civil penalties levied by any governmental entity or agency against Vendor, its employees or agents and their firms, solely to the extent based on or arising out of Committee's gross negligence, or knowing violation of known applicable federal, state, or local laws.

5. **Vendor's Liability**

- a. *Total Liability.* Vendor's total liability to Committee, its successors, and assigns will be limited to amounts paid by Vendor under this Agreement in the preceding one (1) month before the occurrence of the liability.
- b. ***NO WARRANTIES. Vendor PROVIDES ALL SERVICES "AS IS" AND "AS AVAILABLE" AND HEREBY EXPRESSLY DISCLAIMS ALL WARRANTIES. EXCEPT AS STATED IN THIS AGREEMENT, Vendor MAKES NO WARRANTIES OF ANY KIND OR NATURE WHETHER EXPRESSED OR IMPLIED INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR USE, OR WARRANTIES OF ANY PRODUCT PROVIDED BY A THIRD PARTY Vendor OR OF ANY DELIVERABLES.***

6. **Confidentiality**

- a. Vendor agrees that it will not at any time, in any fashion, form or manner, either directly or indirectly, disclose or communicate to any person or entity, any non-public or proprietary information concerning the Committee or its operations or

programs, or any other information deemed confidential by the Committee.

- b. Committee agrees that it will not at any time, in any fashion, form or manner, either directly or indirectly, disclose or communicate to any person or entity, any non-public or proprietary information concerning the Vendor or its operations or programs, or any other information deemed confidential by the Vendor.

## **7. Ownership of Work Product and Release**

- 7.1. Committee may provide Vendor with certain materials for inclusion in advertisements produced for the Committee, including, without limitation, research, photographs, and/or video and audio recordings. Committee will secure all necessary licenses, consents, authorizations and releases from third parties for the use of such materials by Vendor in the advertisements produced for the Committee, and will indemnify and hold Vendor harmless for failure to do so.
- 7.2. Vendor agrees that any and all advertising copy, writings and materials, all sound recordings, all graphic, pictorial and audiovisual works, and all other works, in any form whatsoever, whether written, electronic or otherwise, created or produced by Vendor in the course of its performance of services under this Agreement will become and remain the exclusive property of the Committee, and will be deemed works for hire created for the Committee for purposes of the Copyright Law of 1976; and all copyright and any other rights in and to such writings and materials will belong to the Committee.
- 7.3. Committee agrees that, after the termination of this Agreement, Vendor may request use of works for hire created pursuant to this Agreement, and Committee's consent may not be unreasonably withheld.

## **8. Relationship Between the Parties**

It is understood and agreed that Vendor is an independent contractor and will have no authority whatsoever to incur any liability or expense on behalf of the Committee except in accordance with the terms of this Agreement.

## **9. Term and Termination**

- 9.1. This Agreement will come into effect as of the date first above written and will continue in effect, unless this Agreement is terminated pursuant to the provisions of this Section 9.
- 9.2. The provisions of sections 2, 3, 4, 5, 6 and 7 of this Agreement will survive termination of this Agreement and will continue in effect until both parties have fulfilled all of their

obligations under those provisions.

- 9.3. Either party may terminate this Agreement for any reason, provided that fifteen (15) days' notice is given by the other party. The fifteenth day after notice is provided is considered the effective date of the termination.

**10. Miscellaneous**

- 10.1 Neither party to this Agreement may delegate its obligations or assign its rights under this Agreement to any other person or entity without the prior written consent of the other.
- 10.2 This Agreement will be governed by and construed in accordance with the laws of the state of California without regard to California's choice of law rules. Any action whatsoever to enforce any right under this Agreement will be brought only in the courts of the California.
- 10.3 Any notice required or desired to be given under this Agreement will be deemed sufficient if sent by electronic mail, notice of receipt requested, or by facsimile, to the address set forth below, or to such other address as either party may designate by like notice:

- 10.4 This Agreement constitutes the entire agreement of the parties relating to the subject matter contained in this Agreement, supersedes all prior written and oral agreements and understandings relating to such subject matter and cannot be modified or amended except by a written instrument executed by both parties to this Agreement.

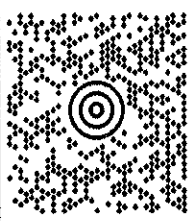

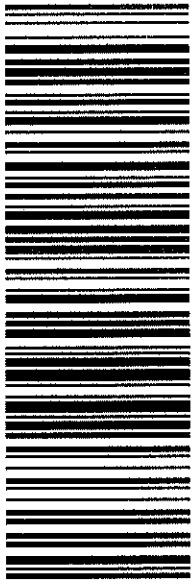

The enclosed Complaint states the specific allegations which are being brought against you. You have **30 days** to respond to these allegations in writing, if you should choose to do so.


After a thorough review of the evidence, including any information you may provide, Commission staff will determine whether there is basis to proceed with further prosecution. Should Commission staff determine that there is no basis to proceed with further prosecution of the enclosed Complaint, you will be notified in writing that the above-referenced case has been administratively dismissed pursuant to Ga. Comp. R. & Reg. r. 189-2.03(5).

If Commission staff determines that there is a basis to proceed, the Complaint will be presented to the Commission at a preliminary hearing where the Commission will determine whether there are reasonable grounds to believe that you have violated the Act.

Enclosed please find and respond to the attached subpoenas that have been issued in this complaint. The date for response to these subpoenas is October 31<sup>st</sup>, 2019.



**COMPLAINT**

COMES NOW, the Georgia Government Transparency and Campaign Finance Commission (hereinafter “Commission”) and files this Complaint (hereinafter “Complaint”) against New Georgia Project, Inc. and New Georgia Project Action Fund, Inc. (hereinafter “Respondent NGP” and “Respondent NGP(AF)” respectively, and “Respondents” collectively) and asserts the following:

1.

Respondent NGP may be served according to law through their registered agent, Nse Ufot, at 165 Courtland Street, Suite A231, Atlanta, GA, 30303, USA.

2.

Respondent NGP(AF) may be served according to law through their registered agent, The Corporation Trust Company at Corporation Trust Center, 1209 Orange Street, Wilmington, DE 19801.

3.

On or about April 7, 2017, Respondent NGP filed paperwork in the state of Delaware to incorporate as a Delaware corporation. Prior to Respondent NGP's incorporation, Respondent NGP was a project of Third Sector Development, Inc. Shortly after incorporating in Delaware, on or about May 31, 2017, Respondent NGP registered with the Georgia Secretary of State to conduct business in Georgia as a Foreign Nonprofit Corporation. Respondent NGP was issued a favorable Determination Letter from the IRS on February 21, 2019 that granted Respondent NGP 501(c)(3) status as a public charity.

4.

Nse Ufot serves as the executive director of Respondent NGP and Respondent NGP(AF)

5.

According to information on Respondent NGP's website, Respondent NGP is a 501(c)(3), non-partisan organization that seeks to register and civically engage Georgians who are between the ages of 18-26, people of color, or unmarried women. New Georgia Project Home/About, <https://newgeorgiaproject.org/about/> (last visited September 17, 2019). See Exhibit A.

6.

On or about March 21, 2017, Respondent NGP(AF) filed paperwork in the state of Delaware to incorporate as a Delaware corporation. Respondent NGP(AF) has not registered with the Georgia Secretary of State nor has Respondent NGP(AF) been issued a favorable Determination Letter from the IRS granting them 501(c)(4) status.

7.

According to its website, Respondent NGP(AF) is a 501(c)(4) that exists to increase the civic participation of underrepresented and underserved communities of color. “Respondent NGP(AF) does this by engaging in local and state political campaigns, in support of, or opposition to, ballot measures, referendums, recalls, initiatives and candidacies for local and state offices.” New Georgia Project Action Fund Home Page, <https://www.ngpaf.org/> (last visited September 17, 2019). See Exhibit B.

8.

Upon information and belief, during the 2018 state-wide elections, Respondents accepted contributions and made expenditures advocating the election of certain candidates. Therefore, Respondents are subject to the jurisdiction of the Commission. O.C.G.A. §§ 21-5-2, 6, and 34.

9.

Upon information and belief, in 2019, Respondents accepted contributions and made expenditures designed to bring about the approval by voters of a proposed question which appeared on the Gwinnett County ballot. Therefore, Respondents are subject to the jurisdiction of the Commission. O.C.G.A. §§ 21-5-2, 6, and 34.

10.

The Georgia General Assembly has tasked the Commission with ensuring compliance with the Act and enforcing the Act. To that end, the Commission is vested with the authority to initiate investigations and complaints on its own cognizance. See O.C.G.A. §§ 21-5-2, 6.

11.

The Georgia Government Transparency and Campaign Finance Act ("Act") requires that any action alleging a violation regarding a four-year term public office or candidate for office

must commence within five years from the date of the violation. All other violations must commence within three years from the date of the violation. The violations alleged in this Complaint occurred in 2018 and 2019; therefore, this action has been timely commenced.

**I. Respondents' Failure to Register and Report as an Independent Committee**

12.

O.C.G.A. § 21-5-3 (15) defines "independent committee" as "any committee, club, association, partnership, corporation, labor union, or other group of persons, other than a campaign committee, political party or political action committee, which receives donations during a calendar year from persons who are members or supporters of the committee and which expends such funds either for the purpose of affecting the outcome of an election for any elected office or to advocate the election or defeat of any particular candidate."

13.

O.C.G.A. § 21-5-34 (f)(1) requires "[a]ny independent committee which accepts contributions or makes expenditures for the purpose of affecting the outcome of an election or advocates the election or defeat of any candidate shall register with the [Georgia Government Transparency and Campaign Finance Commission] prior to accepting contributions or making expenditures. . . ."

14.

O.C.G.A. § 21-5-3(a)(1) requires that the chairperson or treasurer of each independent committee file required disclosure reports with the Commission. An independent committee must file disclosure reports for their contributions and expenditures on the first day of each of the two calendar months preceding any such election and two weeks prior to the date of such election. Within the two-week period prior to the date of such election the independent

committee shall report within two business days any contributions or expenditure of more than \$1,000.00. The independent committee shall file a final report prior to December 31 of the election year and shall file supplemental reports on June 30 and December 31 of each year that such independent committee continues to accept contributions or make expenditures. O.C.G.A. § 21-5-34(f)(1).

15.

Respondents accepted contributions and made expenditures that advocated the election of Stacey Abrams for the Democratic candidate for Governor of Georgia in the primary election held on May 22, 2018. In addition to advocating the election of Ms. Abrams in the general election held on November 6, 2018, Respondents accepted contributions and made expenditures to advocate the election of Democratic candidates Sarah Riggs Amico, Charlie Bailey, John Barrow, Fred Swann, Richard Keatley, Janice Laws, Otha Thornton, Lindy Miller, and Dawn Randolph. After the general election, Respondents continued to accept contributions for the December 4, 2018 runoff to support Mr. Barrow and Ms. Abrams. Specifically, Respondents made expenditures to canvass neighborhoods throughout Georgia. See Exhibit C.

16.

Respondents never registered as an independent committee with the Commission in 2017 or 2018; therefore, Respondents violated O.C.G.A. § 21-5-34(f)(1) when they failed to register with the Commission as an independent committee prior to the acceptance of contributions and making of expenditures.



17.

Because Respondents accepted contributions and made expenditures to advocate for the election of candidates who participated in the 2018 primary, general, and run-off elections, Respondents should have filed the following disclosure reports:

- a. Disclosure report due two months prior to the election held on May 22, 2018;
- b. Disclosure report due one month prior to the election held on May 22, 2018;
- c. Disclosure report due two weeks prior to the election held on May 22, 2018;
- d. A June 30, 2018 supplemental disclosure report;
- e. Disclosure report due two months prior to the election held on November 6, 2018;
- f. Disclosure report due one month prior to the election held on November 6, 2018;
- g. Disclosure report due two weeks prior to the election held on November 6, 2018;
- h. Disclosure report due two weeks prior to the election held on December 4, 2018; and,
- i. December 31, 2018 supplemental disclosure report.

18.

Respondents failed to file any required disclosure reports containing the contributions or expenditures associated with their advocacy of Democratic candidates participating in the 2018 primary, general, and run-off elections; therefore, Respondents violated O.C.G.A. § 21-5-34(f)(1) nine (9) times.

## **II. Respondents' Failure to Register and Report as a Ballot Committee**

19.

A ballot committee is a non-candidate campaign committee that accepts contributions or makes expenditures designed to bring about the approval or rejection of a proposed

constitutional amendment, a state-wide referendum, or a proposed question which is to appear on the ballot in any state, county, or municipal election. O.C.G.A. § 21-5-2(2).

20.

O.C.G.A. § 21-5-34(a)(2) requires a ballot committee accepting contributions or making expenditures designed to bring about the approval or rejection of a proposed question which is to appear on the ballot in a county election to register with the election superintendent in the county of election.

21.

Once a ballot committee supporting or opposing a ballot question appearing on a county ballot has received contributions totaling more than \$500 or has made expenditures totaling more than \$500, the ballot committee is required to file campaign disclosure reports with the county election superintendent in accordance with the filing schedule contained in O.C.G.A. § 21-5-34(a)(2)(B).

22.

O.C.G.A. § 21-5-34(a)(2)(B) requires a ballot committee to file campaign disclosure reports, “15 days prior to the date of the election; and a final report shall be filed prior to December 31 of the election year.” O.C.G.A. § 21-5-34 (2)(B).

23.

A proposed question relating to the expansion of transit appeared on the Gwinnett County ballot during the March 19, 2019 special election.

24.

Respondents accepted contributions and made expenditures exceeding \$500 that were designed to bring about the approval of the ballot question relating to transit expansion on the March 19, 2019 Gwinnett County Ballot. See Exhibit D.

25.

Respondents never registered as a ballot committee in 2018 or 2019; therefore, Respondents violated O.C.G.A. § 21-5-34(a)(2) when they failed to register with the Gwinnett County election superintendent as a ballot committee prior to the acceptance of contributions and making of expenditures.

26.


Because Respondents exceeded \$500 in contributions and/or expenditures, Respondents were required to file a campaign disclosure report 15 days prior to the election held on March 19, 2019. Respondents failed to file a campaign contribution disclosure report on March 14, 2019 in violation of O.C.G.A. § 21-5-34(a)(2).

WHEREFORE, Commission staff pray as follows:

- a) That process issue and Respondents be served with a copy of the Complaint;
- b) That, in the event that a violation of the Campaign Finance Act is substantiated, Respondent be appropriately sanctioned by the Commission for violation of the Campaign Finance Act in accordance with O.C.G.A. § 21-5-6(14); and,
- c) That Respondents be required to file unfiled disclosure reports as required by law.


