The CPAC Foundation is proud to present our 2022 Ratings of Congress. I am gratified that this represents 52 continuous years of publication providing conservatives, from the local activist to those in the highest levels of government, a guide to who is representing our principles in Congress.

I wish I could say that Congress helped tackle the problems our country faced that I described in 2021 on these pages. However, sad to say, they instead have poured oil on the fires of inflation, massive deficits, increasing crime numbers, and illegal migration by voting for the Biden left wing agenda.

In some cases they were aided by RINO/establishment Republicans, many of them Old Bulls who announced their retirement, that stands out in the bills we rated. Perhaps most shameful is the 4,155 page, \$1.7 trillion Omnibus spending bill passed two days before Christmas with Republican leadership's acquiescence.

By following our ratings, you can see how the continuing resolutions that kept the government funded were first extended, then cut off so members were trapped into approving the bill or shutting down the government at Christmas.

CPAC researches and selects a range of bills to evaluate a member's adherence to conservative principles. We begin by defining conservatism (i.e., the political philosophy that sovereignty resides in the person).

Next, we apply our understanding of the proper role of government (i.e., protecting Life, Liberty, and Property). Then, we select bills that focus on Ronald Reagan's philosophy of the "three-legged stool":

- 1) **Fiscal and Economic:** taxes, budgets, regulation, spending, healthcare, and property;
- 2) **Social and Cultural:** Second Amendment, religion, life, welfare, and education; and
- 3) **National Security:** preserving our nation's security by maintaining a strong national defense.

The wide range of issues covered are designed to give citizens an accurate assessment of how Members of Congress view the role of government in an individual's life.

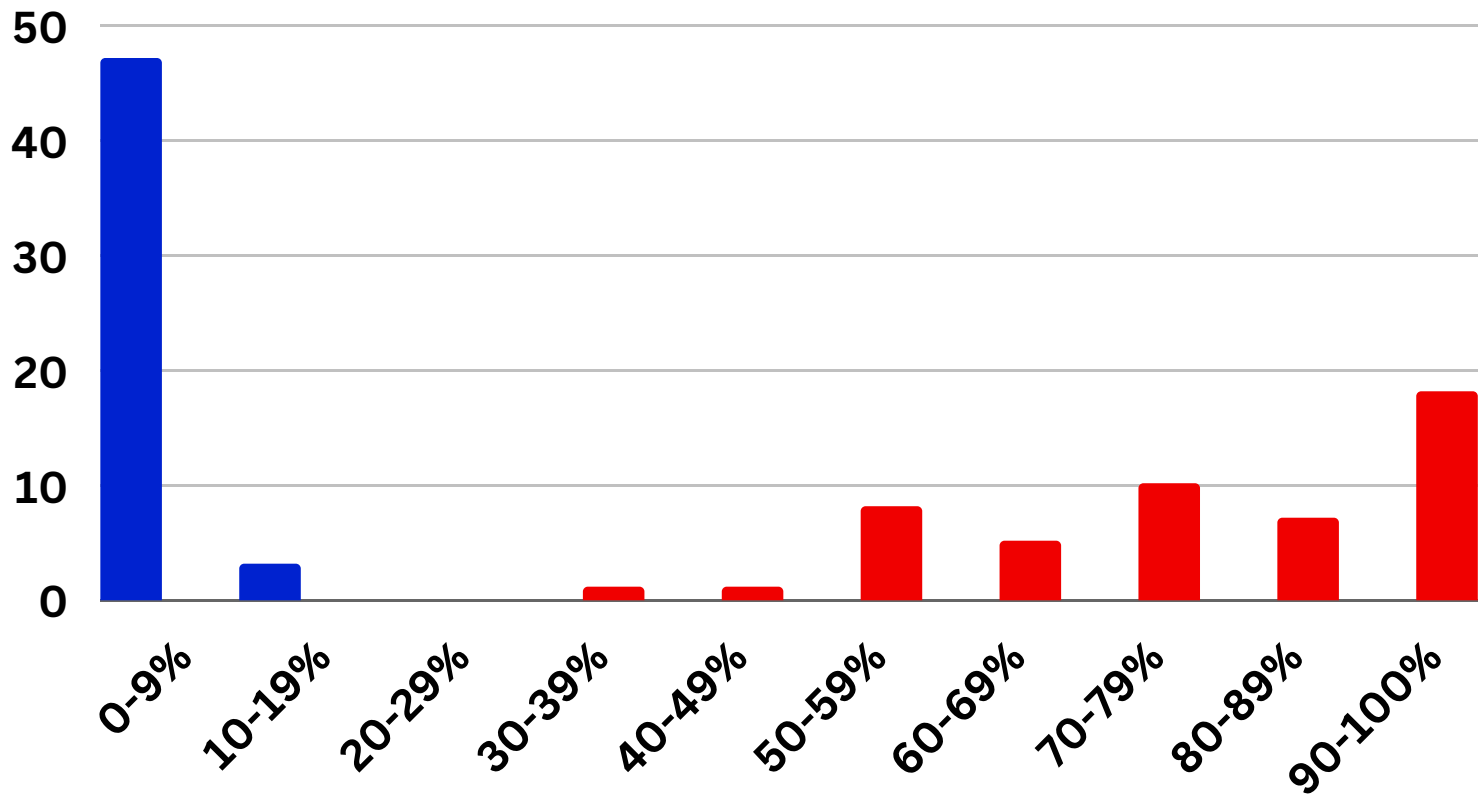

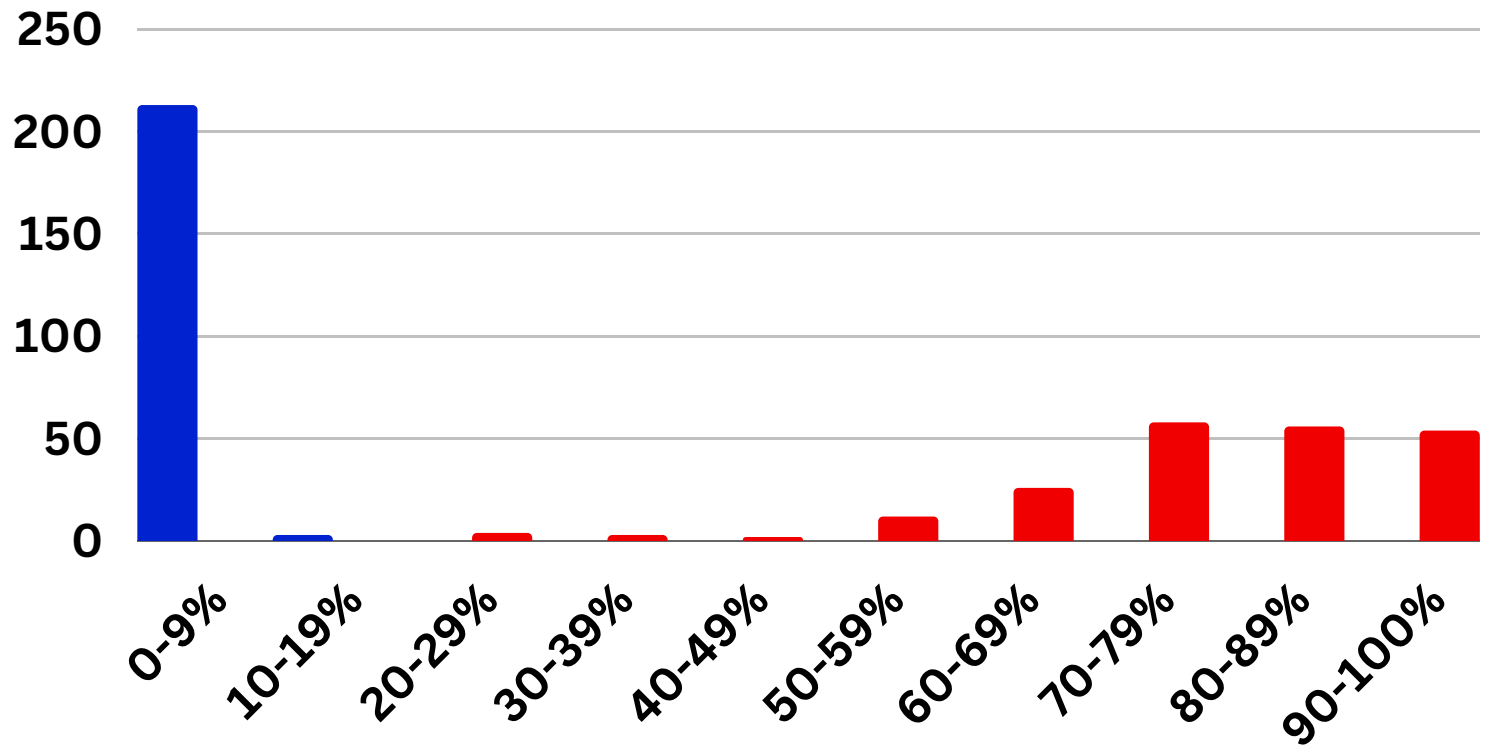

**(Roll Call 9) HR 5746 Federalizing State Elections and Weakening Ballot Integrity.**

This bill, known as the “Freedom to Vote: John R. Lewis Act,” federalizes state elections and makes unelected bureaucrats within the Department of Justice arbiters of election law. CPAC opposes this attempt to federalize state elections and weaken election integrity and opposed this bill. The Senate defeated the bill on January 19, 2022 by a vote of 49-51.

---

**(Roll Call 62) HR 6617 (Sen. Cruz Amd.) Defunding Chinese Coronavirus Job Mandates in Schools.**

The Sen. Cruz (CPAC Lifetime 97%) amendment to the Continuing Resolution prohibits funding for schools that enforce Chinese Coronavirus job mandates on children. CPAC believes that parents should make these decisions and supported this amendment. The Senate defeated the amendment on February 17, 2022, by a vote of 44-49.

---

**(Roll Call 63) HR 6617 (Sen. Braun Amd.) Stopping the Senate From Violating its Fiscal Rules.**

The Sen. Braun (CPAC Lifetime 93%) amendment to the Continuing Resolution would force the Senate to abide by rules that prohibit new programs that are not paid for and require balanced budgets when dealing with budget resolutions. CPAC has long opposed the Senate breaking the ‘pay as you go’ rule in order to achieve a balanced budget and supported this amendment. The Senate defeated the amendment on February 17, 2022, by a vote of 47-45 (60 votes were required).

---

**(Roll Call 67) SJ Res 32 Preventing The Use Of Government Health To Force Chinese Coronavirus Jobs.**

This Congressional Review Act resolution would disapprove a rule promulgated by the Center for Medicare and Medicaid that withholds federal funds from any organization that does not mandate Chinese Coronavirus jobs for all healthcare staff. CPAC disapproves of government funding used to control people and force behavior and supported this resolution. The Senate passed the resolution by a vote of 49-44 on March 2, 2022, but the resolution was not voted on in the House.

---



**(Roll Call 71) HR 3076 Postal “Reform” Act Without Reform.**

This union-backed bill, known as the “Postal Service Reform Act,” does nothing to actually reform the postal service and instead bails out the pension system that is deeply in debt. The bill removes the requirement that USPS prepay their pension health benefits. CPAC believes this is a fiscally irresponsible way of avoiding competition with private delivery services and opposed the bill. The Senate passed the bill on March 8, 2022, by a vote of 79-19 and the bill later became law.

---

**(Roll Call 76) HR 2471 (Sen. Braun Amd.) Removing Earmarks.**

The Sen. Braun (CPAC Lifetime 93%) amendment to the previous year’s appropriations bill (FY 22) prohibits funds from being used for earmarks. CPAC has long opposed earmarks that use the taxpayer’s money to buy votes and supported this amendment. The Senate defeated the amendment on March 10, 2022, by a vote of 35-64.

---

**(Roll Call 81) SJ Res 37 Removing Mask Mandates.**

This resolution uses the Congressional Review Act to disapprove of a rule that would require people to wear masks on “conveyances and transportation hubs.” CPAC believes masks should not be mandated by government and should at most be a personal choice. Therefore CPAC supported this resolution. The Senate passed the resolution on March 15, 2022, by a vote of 57-40 but it was not taken up in the House.

---

**(Roll Call 109) HR 4521 Pouring Gasoline on an Inflationary Fire.**

This bill, known as the “United States Innovation and Competition Act of 2021,” spends \$320 billion of taxpayer funds on union-favored special interests. CPAC believes the free market, not government, should dictate investment into private industry, and opposes fueling an inflationary fire through \$320 billion in new discretionary spending and opposed this bill. The Senate passed the bill on March 28, 2022, by a vote of 68-28 and the bill was signed into law.

---



**(Roll Call 134) PN 1783 Nomination of Ketanji Brown Jackson to the Supreme Court.**

CPAC opposed her nomination not only because of her judicial philosophy, which dismisses originalism, but because her judicial record showed she was weak in criminal cases, particularly child exploitation cases. CPAC also believes that any judge incapable of defining what a woman is should not be permitted to sit on the Supreme Court. The Senate confirmed her nomination on April 7, 2022, by a vote of 53-47.

---

**(Roll Call 140) SJ Res 41 Preserving Access to Abortion.**

This resolution uses the Congressional Review Act to disapprove of a rule submitted by Health and Human Services that vaguely ensures “access to family planning services” a euphemism for access to abortion. CPAC believes abortion is always a human tragedy and therefore supports restrictions on the practice and supported this resolution. The Senate defeated the resolution on April 27, 2022, by a vote of 49-49.

---

**(Roll Call 170) S 4132 Overriding State Restrictions on Abortion.**

This bill overrides state restrictions on abortion at any time during pregnancy. CPAC believes abortion is always a human tragedy and according to CPAC’s 2023 straw poll, 73% of respondents believed that abortion should be regulated at the state level. CPAC supports state restrictions on the practice and so opposed this bill. The Senate refused to end debate on a motion to bring the bill to the floor on May 11, 2022, by a vote of 49-51.

---

**(Roll Call 191) H.R. 7691 Sending Another \$40 Billion Overseas Without Proper Oversight.**

This bill spends an additional \$40 billion in taxpayer funds to assist Ukraine through economic, humanitarian, and military aid. This bill does not allow for the spending to be overseen by a special inspector general and was an amount more than three times what European nations as a whole had provided to Ukraine. According to CPAC’s 2023 straw poll, nearly 80% of respondents disapproved of the billions of dollars previously given to Ukraine. CPAC believes all foreign aid and assistance should at the very least be targeted and made accountable to the United States’ taxpayers and therefore opposed this bill. The Senate passed the bill on May 19, 2022, by a vote of 86-11 and the bill was signed into law.

---



**(Roll Call 192) S 4008 More Wasteful Grants for Chinese Coronavirus Relief.**

This bill would set up another grant program in the Small Business Administration to provide funds to certain businesses, such as gyms and concert promoters that were impacted by the pandemic. CPAC opposes this bill knowing that billions of dollars have already been spent on “impact aid” with large sums of it being misused (including millions to groups like Planned Parenthood) and over 100 billion dollars of Chinese Coronavirus aid being stolen due to a lack of oversight. The Senate refused to end debate on the motion to bring the bill to the floor on May 19, 2022, by a vote of 52-43 (60 votes were required).

**(Roll Call 210) HR 350 Giving Biden’s Politicized DOJ More Power to Wield Against Conservatives.**

This bill would encourage and expand the FBI’s targeting of American Citizens. For example, it would authorize the assignment of a special agent for each of 56 field offices to act as a “hate crime liaison.” Considering recent abuses by the FBI like labeling parents that attend school board meetings as domestic terrorists and identifying Catholic groups as having a high propensity to produce “white nationalists,” CPAC fears the grave misuse of this legislation and opposed the bill. The Senate refused to end debate on a motion to bring the bill to the floor on May 26, 2022, by a vote of 47-47.

**(Roll Call 242) S2938 Expanding Gun Control.**

This bill, the so-called “Bipartisan Safer Communities Act,” includes various gun control measures including expanded background checks for those under 21 and provides additional funding to states that administer “red flag” laws which allow judges to arbitrarily seize firearms from individuals even when no crime has been committed. CPAC continues to support the founders’ belief in the Second Amendment and opposed this bill. The Senate passed the bill on June 23, 2022, by a vote of 65-33 and the bill later became law.

**(Roll Call 271) H.R. 4346 Stealing from Taxpayers to Fund a Government-Favored Industry.**

This bill, known as the “CHIPS Act,” takes \$250 billion from taxpayers to give to the government-favored semiconductor industry without necessary protections that would prevent Chinese linked firms from being the primary beneficiaries. CPAC does not believe the government should use taxpayer funds to support one industry over another and opposed this bill. The Senate passed the bill on July 27, 2022, by a vote of 64-33 and the bill was signed into law.





**(Roll Call 281) Treaty Doc. 117-3 (Sen. Paul Amd.) Putting America First in Foreign Policy Decisions.**

The Sen. Paul (CPAC Lifetime 97%) amendment to the resolution backing Finland's and Sweden's accession to NATO would ensure that the treaty does not undermine ArtI.S8.C11.3 of the Constitution which grants Congress the exclusive power to declare war. CPAC supports Congress' constitutional oversight on military powers, opposes giving the executive branch unilateral authority to engage in war, and supported the amendment. The Senate failed to adopt the Amendment on August 3, 2022, by a vote of 10-87.

---

**(Roll Call 283) SJ Res 55 Repealing Reforms to the Government Permit Process.**

This Congressional Review Act resolution overturns elements of the National Environmental Policy Act which delays construction projects, kills jobs and limits much needed American energy infrastructure. CPAC supported these needed reforms and supported this resolution. The Senate passed the resolution on August 4, 2022, by a vote of 50-47 but the resolution was not taken up in the House.

---

**(Roll Call 294) HR 5376 (Sen. Lankford Amd.) More Funding for the Border.**

The Sen. Lankford (CPAC Lifetime 90%) amendment to the Budget Reconciliation bill would provide additional funding for what is known as Title 42, whereby illegal aliens can be turned away at the border before they have claimed asylum. CPAC believes federal immigration laws should be enforced and supported this amendment. The Senate defeated the amendment on August 7, 2022, by a vote of 50-50.

---

**(Roll Call 303) HR 5376 (Sen. Kennedy Amd.) Boosting Domestic Energy Production.**

The Sen. Kennedy (CPAC Lifetime 81%) amendment to the Budget Reconciliation bill requires lease sales for oil and gas leases on the outer continental shelf. CPAC supports all forms of energy, does not believe government should support one form of energy over another and supported this amendment. The Senate defeated the amendment on August 7, 2022 by a vote of 50-50.

---



**(Roll Call 309) HR 5376 (Sen. Cruz Amd.) Removing the Massive Funding Increase for the IRS.**

The Sen. Cruz (CPAC Lifetime 97%) amendment to the Budget Reconciliation bill would remove the \$80 billion increase for the IRS and the authorization for 87,000 new IRS employees which would make the IRS bigger than the Pentagon, State Department, and Border Patrol combined. CPAC believes the IRS has a poor record on harassing and turning down tax exemptions for advocacy organizations among other things and supported this amendment. The Senate defeated the amendment on August 7, 2022, by a vote of 50-50.

---

**(Roll Call 323) HR 5376 (Sen. Thune Amd.) Preventing Tax Increases on Small Businesses.**

The Sen. Thune (CPAC Lifetime 84%) amendment to the Budget Reconciliation bill reverses a tax provision that unfairly raises taxes for small businesses. The provision requires any small business with private equity in its capital structure to be considered a corporate subsidiary and subject to taxation as a large corporation. CPAC opposes raising taxes on small businesses, especially at a time of rampant inflation, and supported this amendment. The Senate passed the amendment on August 7, 2022 by a vote of 57-43.

---

**(Roll Call 325) HR 5376 The Inflation Expansion Act.**

This bill, the so-called "Inflation Reduction Act," includes a long list of measures that raise taxes, feed inflation and advance the left's agenda to reduce America's energy independence. Examples include funding for the IRS to add 87,000 employees, price controls on some drugs (which creates shortages and raises prices - even for other drugs), and adding tax credits for those who get renewable energy (including electric cars) and solar from union-approved sources. The bill "pays" for this through a minimum corporate tax and a 1% stock transfer tax among others. CPAC opposes this massive increase in government and opposed this bill. The Senate passed the bill on August 7, 2022, by a vote of 51-50, with the Vice President breaking the tie.

---

**(Roll Call 343) Treaty Document 117-1 Raising the Cost of Air Conditioning.**

This treaty strengthens Americans' bondage to the liberal climate regime. It bans the use of hydrofluorocarbons (HFCs) in refrigerants for the U.S. while once again making it easier for China to comply with the Montreal Protocol. Ironically, HFCs were championed as an ozone friendly replacement to Freon. Now, these same HFCs are said to cause climate change. The treaty will force the U.S. to phase out HFCs quickly, but China will have ten years to comply, a timetable akin to the disastrous Paris Climate Treaty. CPAC opposes this ratification. The Senate ratified the treaty on September 21, 2022, by a vote of 69-27.

---



**(Roll Call 351) HR 6833 Forcing a Christmas Vote on the Budget.**

This Continuing Resolution postpones the Fiscal Year 2023 appropriation until just before Christmas. This move prevents Congress from having time to pass the full 12 appropriation bills separately and continues the trillions of dollars in debt that has fed inflation. CPAC supports a CR that would extend into the new year when there would be a change in congressional leadership and opposed this bill. The Senate passed the bill on September 29, 2022, by a vote of 72-25 and the bill later became law.

---

**(Roll Call 362) HR 8404 An Attack on Religious Rights.**

This bill, the so-called "Respect for Marriage Act," is a trojan horse that will be used to decimate religious liberty. This legislation would force people of faith and religious-affiliated institutions to violate their sincerely-held beliefs. Those individuals who choose to adhere to tenets of their faith and moral convictions would face costly litigation. And for religious-affiliated institutions, the legislation would empower President Biden's politicized IRS to threaten their tax-exempt status. Sen. Lee (CPAC 99% lifetime rating) offered an amendment which would have given these necessary protections which are not included in this bill. The Senate passed the bill on November 29, 2022, by a vote of 61-36 and the bill later became law.

---

**(Roll Call 390) S J Res 60 Repealing New Rule That Hurts Charter Schools.**

This resolution repeals a new rule that restricted funds for the Federal Charter School program. CPAC disapproves of the union-backed Biden Administration that will do anything to hurt charter schools. CPAC unwaveringly supports school choice and parental rights and therefore supported this resolution. The Senate defeated the resolution on December 24, 2022, by a vote of 49-49.

---

**(Roll Call 399) HR 1437 Giving the Democrat's Leverage in the Budget Fight.**

This Continuing Resolution exacerbated the government's reckless inflationary spending while giving the Democrat's leverage in the budget fight by giving Democrat's another week to negotiate a spending deal. Allowing for the first-ever lame-duck omnibus before the new majority takes power. CPAC opposed this bill. The Senate passed the bill on December 15, 2022, by a vote of 71-19 and the bill later became law.

---



**(Roll Call 408) HR 2617 (Motion to Waive All Applicable Budgetary Discipline) Waiving All Rules Requiring a Balanced Budget.**

This vote allowed the Senate to disregard rules that prohibit new programs that are not paid for and require balanced budgets when dealing with budget resolutions. CPAC opposes violating budgetary discipline and opposed this vote. The Senate passed the bill on December 22, 2022, by a vote of 65-31 and the motion to waive the rules was successful.

---

**(Roll Call 410) HR 2617 (Sen. Johnson Amd.) Canceling Earmarks.**

The Sen. Johnson (CPAC Lifetime 91%) amendment to the Omnibus Appropriations bill would cancel all 7,500 earmarks. Again, CPAC opposes these earmarks that have led to corruption in the past and are used to buy votes. Therefore, CPAC supported this amendment. The Senate defeated the amendment on December 22, 2022 by a vote of 34-63.

---

**(Roll Call 416) H.R. 2617 (Sen. Cassidy Amd.) Imposing Costly New Mandates on Businesses.**

The Sen. Cassidy (CPAC Lifetime 80%) amendment to the Omnibus Appropriations Act requires employers to make “reasonable accommodations” in the workplace for pregnant workers. CPAC notes that “reasonable accommodation” is ill defined and could include facilitating an abortion, and opposed this amendment. The Senate passed the amendment on December 22, 2022 by a vote of 73-24.

---

**(Roll Call 421) HR 2617 A Lame-Duck Budget With Record Non-Defense Spending Increases.**

This is the appropriations bill for the entire \$1.7 Trillion federal budget for Fiscal Year 2023, and it sets overall spending limits by agency or program. This new budget includes nearly \$800 billion in non-defense funding, a 9.3% increase—\$68 billion—over Fiscal Year 2022. This represents the highest level of non-defense funding ever. Passed only 3 days after being introduced, CPAC vehemently opposes this method of passing the budget, including allowing Democrat’s to pass the first-ever lame-duck omnibus before the new majority takes power, and opposed this bill. The Senate released the bill on December 19, 2022 and passed the bill on December 22, 2022 by a vote of 68-29.

**(Roll Call 6) HR 1836 Diminishing Active Military Service.**

This bill, known as the “Guard and Reserve GI Bill Parity Act,” would cost taxpayers \$5 billion over 10 years by expanding access to full veterans benefits by rewarding annual training engaged in by National Guard and Reserve members in addition to active military service. The bill provides no spending offset for the costs associated with the increased benefits. CPAC points out any call-up of reserves to active duty is already included in time served and diminishes the role of active military service and opposed this bill. The House passed the bill on January 12, 2022 by a vote of 287-135. The bill was not taken up by the Senate.

---

**(Roll Call 9) HR 5746 Federalizing State Elections and Weakening Ballot Integrity.**

This bill, known as the “Freedom to Vote: John R. Lewis Act,” federalizes state elections and makes unelected bureaucrats within the Department of Justice arbiters of election law. CPAC opposes this attempt to federalize state elections and weaken election integrity and opposed this bill. The House passed the vote on January 13, 2022 by a vote of 220-203. The bill failed to advance in the Senate.

---

**(Roll Call 27) HR 4521 (Rep. Perry Amd.) Withdrawing From the UN Framework Convention on Climate Change.**

The Scott Perry (CPAC Lifetime 97%) amendment to the “United States Innovation and Competition Act” withdraws the United States from the United Nations Framework Convention on Climate Change (UNFCCC). The UNFCCC requires the U.S. to spend billions of dollars in commitments to other countries and forces changes in U.S. energy production which are not being followed by other countries, such as India and China. CPAC supports America’s energy independence and supported this amendment. The amendment was defeated on February 3, 2022 by a vote of 196-235.

---

**(Roll Call 31) HR 4521 Pouring Gasoline on an Inflationary Fire.**

This bill known as the “United States Innovation and Competition Act of 2021,” spends \$320 billion of taxpayer funds on union-favored special interests. CPAC believes the free market, not government, should dictate investment into private industry, and opposes fueling an inflationary fire through \$320 billion in new discretionary spending and opposed this bill. The House passed the bill on February 4, 2022 by a vote of 222-210 and the bill was signed into law.

---



**(Roll Call 38) HR 3076 Postal “Reform” Act Without Reform.**

This union-backed bill, known as the “Postal Service Reform Act,” does nothing to actually reform the postal service and instead bails out the pension system that is deeply in debt. The bill removes the requirement that USPS prepay their pension health benefits. CPAC believes this is a fiscally irresponsible way of avoiding competition with private delivery services and opposed the bill. The House passed the bill on February 8, 2022 by a vote of 342-92 and the bill later became law.

---

**(Roll Call 79) HR 963 (Fitzgerald Amd.) Protecting Employers from Costly Litigation.**

The Fitzgerald (CPAC Lifetime 90%) amendment to the “Fair Act” removes a provision from the bill that bans the use of arbitration for non-union employees while allowing it for unionized employees. CPAC believes this blatant sop to the trial lawyers, as well as the unions, is highly discriminatory. CPAC supported this amendment. The amendment was defeated on March 17, 2022 by a vote of 184- 246. The underlying bill was not taken up by the Senate.

---

**(Roll Call 90) HR 5706 New Mandates on the Transportation Industry.**

This bill expands government mandates and the regulatory power of the Department of Transportation under the guise of preventing sexual harassment. CPAC opposes expanding the authority of the federal government over the private sector and opposed this bill. The House passed the bill on March 30, 2022 by a vote of 339-85. The bill was not taken up by the Senate.

---

**(Roll Call 94) H.R. 5547 Complicating the Process for Economic Development.**

This bill, known as the “CEDS Act,” would require businesses who request funds from the Economic Development Administration to provide a litany of non-economic impacts from the proposed developments. CPAC believes this policy puts smaller-sized firms at a disadvantage by vastly expanding application requirements and opposed this bill. The House passed the bill on March 30, 2022 by a vote of 304-122. The bill was not taken up by the Senate.

---

**(Roll Call 102) HR 6833 Forcing a Christmas Vote on the Budget.**

This Continuing Resolution postpones the Fiscal Year 2023 appropriation until just before Christmas. This move prevents Congress from having time to pass the full 12 appropriation bills separately and continues the trillions of dollars in debt that has fed inflation. CPAC supports a CR that would extend into the new year when there would be a change in congressional leadership and opposed this bill. The CR passed the House on March 31, 2022 by a vote of 232-193 and the bill later became law.

---





**(Roll Call 109) HR 1916 Health Insurance Mandates.**

This bill, like Obamacare before it, requires private health insurance plans to cover congenital anomalies. The bill also has a price control feature in that coverage limits and co-pays may not be more restrictive than other benefits. CPAC opposes these mandates that drive up the cost of healthcare for everyone and opposed this bill. The House passed the bill on April 4, 2022 by a vote of 310-110. The bill was not taken up by the Senate.

---

**(Roll Call 115) H.Res. 831 Giving NATO New Non-Defense Responsibilities.**

This resolution would establish a “Center for Democratic Resilience” within NATO tasked with “monitoring and identifying challenges to democracy, human rights, and the rule of law.” Considering the majority of NATO members fail to meet their defense spending obligations, CPAC believes the alliance should prioritize defense rather than invent new roles which could undermine U.S. sovereignty and opposed the resolution. The House passed the resolution on April 5, 2022 by a vote of 362-63.

---

**(Roll Call 123) HR 3807 More Chinese Coronavirus Giveaways.**

This bill, known as the “Restaurant Revitalization Fund Replenishment Act,” includes an additional \$42 billion dollars for a restaurant relief fund and money for other small businesses. CPAC points out that hundreds of billions of taxpayer dollars have already gone unaccounted for, or gone to ineligible recipients and opposed this bill. The House passed the bill on April 7, 2022 by a vote of 223-203. The bill was not taken up by the Senate.

---

**(Roll Call 145) H.R. 7691 Sending Another \$40 Billion Overseas Without Proper Oversight.**

This bill spends an additional \$40 billion in taxpayer funds to assist Ukraine through economic, humanitarian, and military aid. This bill does not allow for the spending to be overseen by a special inspector general and was an amount more than three times what European nations as a whole had provided to Ukraine. According to CPAC’s 2023 straw poll, nearly 80% of respondents disapproved of the billions of dollars previously given to Ukraine. CPAC believes all foreign aid and assistance should at the very least be targeted and made accountable to the United States’ taxpayers and therefore opposed this bill. The House passed the bill on May 10, 2022 by a vote of 368-57 and the bill was signed into law.

---



**(Roll Call 154) HR 1437 (House Version) Wasting Taxpayer Funds To Compete With Private Weather Prediction Services.**

This bill, known as the PRECIP Act, requires the weather service to work with the National Academy of Science to predict precipitation estimates to advise federal agencies, at a cost of \$31 million. CPAC knows it's tough enough to predict tomorrow's weather without devising meaningless forecasts of precipitation in a certain place. CPAC believes the Weather Service already competes with private enterprise on specific forecasts, considers this a further waste of the taxpayer's money and opposed this bill. The House passed this version of the bill on May 11, 2022 by a vote of 333-81.

---

**(Roll Call 163) H.R. 6351 Diverting Tax Dollars to Blue Cities.**

This bill, known as the "Targeting Resources to Communities in Need Act" allows the Biden administration to send taxpayer funds with limited oversight to a narrowly defined "area of persistent poverty." CPAC recognizes many low-income rural areas would be excluded from receiving funds, while cities which persistently vote Democrat to their own demise would be rewarded and opposed this bill. The House passed the bill on May 11, 2022 by a vote of 262-156. The bill was not taken up by the Senate.

---

**(Roll Call 182) HR 5129 Expanding the "Community Services" Program.**

This bill reauthorizes the Community Services Block Grant program and redirects it to satisfy the left's agenda of increasing taxpayer funds to certain areas and increasing handouts those with higher incomes (for example, increasing the threshold for grants to 200% of poverty levels) all at an increase in spending of more than \$1 billion for the first five years. CPAC opposes these grant programs that can easily be corrupted for political purposes and opposed this bill. The House passed the bill on May 13, 2022 by a vote of 246-169. The bill was not taken up by the Senate.

---

**(Roll Call 221) HR 350 Giving Biden's Politicized DOJ More Power to Wield Against Conservatives.**

This bill would encourage and expand the FBI's targeting of American Citizens. For example, it would authorize the assignment of a special agent for each of 56 field offices to act as a "hate crime liaison." Considering recent abuses by the FBI like labeling parents that attend school board meetings as domestic terrorists and identifying Catholic groups as having a high propensity to produce "white nationalists," CPAC fears the grave misuse of this legislation and opposed the bill. The House passed the bill on May 18, 2022 by a vote of 222-203. The bill was defeated in the Senate.

---



**(Roll Call 275) HR 2543 Mandating the Federal Reserve to “Eliminate Economic Disparities.”**

This bill, known as the “Federal Reserve Racial and Economic Equity Act,” interferes with the U.S. banking system with preference based on race. Specifically, the bill calls for the Federal Reserve to “exercise all duties and functions in a manner that fosters the elimination of disparities across racial and ethnic groups with respect to employment, income, wealth, and access to affordable credit.” CPAC opposes violating the principle of equal treatment under the law and opposed this bill. The House passed the bill on June 15, 2022 by a vote of 215-207 but the bill was not taken up by the Senate.

---

**(Roll Call 296) HR 4176 Forcing Federal Agencies to Perpetuate Radical Gender Theory.**

This bill, known as the “LGBTQI+ Data Inclusion Act” requires federal agencies to list and collect radical gender identities when conducting surveys. CPAC opposed this bill. The House passed the bill on June 23, 2022 by a vote of 220-201. The bill was not taken up by the Senate.

---

**(Roll Call 299) S 2938 Expanding Gun Control.**

This bill, the so-called “Bipartisan Safer Communities Act,” includes various gun control measures including expanded background checks for those under 21 and provides additional funding to states that administer “red flag” laws which allow judges to arbitrarily seize firearms from individuals even when no crime has been committed. CPAC continues to support the founders’ belief in the Second Amendment and opposed this bill. The House passed the bill on June 24, 2022 by a vote of 234 -193 and the bill later became law.

---

**(Roll Call 316) H.R. 7900 (Rep. Barbara Lee Amd.) Massive Cuts to Defense Spending.**

The Rep. Barbara Lee (CA-13 CPAC Lifetime 4%) amendment to the National Defense Authorization Act (NDAA) would cut \$100 Billion from defense spending. CPAC supports a robust national defense, opposes blanket non-targeted cuts to defense and opposed the amendment. The House failed to adopt the amendment on July 13, 2022 by a vote of 78-350.

---

**(Roll Call 360) HR 8296 Forcing States to Provide Abortion on Demand.**

This bill, known as the Women’s Health Protection Act, removes all restrictions on abortions. Specifically, this bill allows abortion by telemedicine and prohibits any government entity from interfering with an abortion in any way. The bill would also eliminate parental notification or consent to a minor’s abortion as that might delay an abortion, which is prohibited, and provides no religious conscience protections. CPAC believes abortion is always a human tragedy, supports restrictions on the practice and opposed this bill. The House passed the bill on July 15, 2022 by a vote of 219-210. The bill was not taken up by the Senate.

---



**(Roll Call 362) HR 8297 Directing States to Eliminate Restrictions on Out-Of-State Abortions.**

This bill, known as the “Ensuring Access to Abortion Act,” prohibits any restriction on trafficking women to get abortions across state lines. CPAC believes abortion is always a human tragedy, supports restrictions on the practice and opposed this bill. The House passed the bill on July 15, 2022 by a vote of 223-205. The bill was not taken up by the Senate.

---

**(Roll Call 385) H.R.8373 Violating Conscience Protections.**

This bill, the so-called “Right to Contraception Act,” would overturn commonsense conscience laws and force religious organizations, like the Little Sisters of the Poor, to distribute chemical abortion pills and other abortifacients. CPAC supports conscience protections and opposed this bill. The House passed the bill on July 21, 2022 by a vote of 228-195. The bill was not taken up in the Senate.

---

**(Roll Call 396) HR 6929 Forcing Taxpayers to Bailout Private Pensions.**

This union-backed bill forces taxpayers to spend nearly \$1 billion to pay for pension benefits lost as a result of the bankruptcy of General Motors in 2009. CPAC opposes singling out General Motors employee benefits when other businesses had to deal with the results of “the great recession” and opposed this bill. The House passed the bill on July 27, 2022 by a vote of 254-175 but the bill was not taken up in the Senate.

---

**(Roll Call 404) H.R. 4346 Stealing from Taxpayers to Fund a Government-Favored Industry.**

This bill, known as the “CHIPS Act,” takes \$250 billion from taxpayers to give to the government-favored semiconductor industry without necessary protections that would prevent Chinese linked firms from being the primary beneficiaries. CPAC does not believe the government should use taxpayer funds to support one industry over another and opposed this bill. The House passed the bill on July 28, 2022, by a vote of 243-187 and the bill was signed into law.

---

**(Roll Call 410) HR 1808 Reviving The Assault Weapons Ban.**

This bill revives the Clinton-era assault weapons ban although there is little agreement on what an “assault” weapon is. CPAC supports the founders’ belief in the Second Amendment and opposed this bill. The House passed the bill on July 29, 2022 by a vote of 217-213 but the bill was not taken up by the Senate.

---



**(Roll Call 415) HR 263 Excessive Restrictions on “Big Cat” Ownership.**

This bill, known as the “Big Cat Public Safety Act” would place excessive new restrictions on the ownership of big cats (i.e., lions, tigers, cheetahs, jaguars) in order to restrict the ability of small, community and family-owned zoos to compete with the big zoo industry. CPAC recognizes this bill as a prime example of profit-motivated business competitors petitioning the government to quash competition. For example, the bill was lobbied by Carole Baskin, whose tax-exempt Big Cat Rescue “sanctuary” would be exempt from restrictions in the bill while her competitors would be stifled (a “Tiger King” ending fit for leftist dreams). CPAC opposes this crony measure designed to restrict competition and enrich special interests and opposed this bill. The House passed the bill on July 29, 2022 by a vote of 278-134 and the bill became law.

---

**(Roll Call 420) HR 5376 The Inflation Expansion Act.**

This bill, the so-called “Inflation Reduction Act,” includes a long list of measures that raise taxes, feed inflation and advance the left’s agenda to reduce America’s energy independence. Examples include funding for the IRS to add 87,000 employees, price controls on some drugs (which creates shortages and raises prices - even for other drugs), and adding tax credits for those who get renewable energy (including electric cars) and solar from union-approved sources. The bill “pays” for this through a minimum corporate tax and a 1% stock transfer tax among others. CPAC opposes this massive increase in government and opposed this bill. The House passed the bill on August 12, 2022 by a vote of 220-207 and the bill later became law.

---

**(Roll Call 432) HR 302 Repealing Government Employee Reform.**

This bill eliminates the new Schedule F, class of federal employees created in 2020 that attempted to allow those who hold policy-making positions to be appointed rather than be filled by union protected positions. CPAC has long supported these reforms and opposed this bill. The House passed the bill on September 15, 2022 by a vote of 225-204 but the bill was not taken up by the Senate.

**(Roll Call 469) HR 8888 Giving the Failing VA New Bureaucracies to Manage.**

This bill sets up a new bureaucracy within the Veterans Department, the Office of Food Security, to advise veterans of nutrition assistance programs. CPAC opposes setting up new offices within the VA when it does nothing to alleviate the huge backlog of cases in the VA and opposed this bill. The House passed the bill on September 29, 2022 by a vote of 376-49. The bill was not taken up in the Senate.

**(Roll Call 476) HR 6833 Forcing a Christmas Vote on the Budget.**

This Continuing Resolution postpones the Fiscal Year 2023 appropriation until just before Christmas. This move prevents Congress from having time to pass the full 12 appropriation bills separately and continues the trillions of dollars in debt that has fed inflation. CPAC supports a CR that would extend into the new year when there would be a change in congressional leadership and opposed this bill. The House passed the bill on September 30, 2022 by a vote of 230-201 and the bill later became law.

---

**(Roll Call 513) HR 8404 An Attack on Religious Rights.**

This bill, the so-called “Respect for Marriage Act,” is a trojan horse that will be used to decimate religious liberty. This legislation would force people of faith and religious-affiliated institutions to violate their sincerely-held beliefs. Those individuals who choose to adhere to tenets of their faith and moral convictions would face costly litigation. And for religious-affiliated institutions, the legislation would empower President Biden’s politicized IRS to threaten their tax-exempt status. Sen. Lee (CPAC 99% lifetime rating) offered an amendment which would have given these necessary protections which are not included in this bill. The House passed the bill on December 8, 2022 by a vote of 258-169 and the bill later became law.

---

**(Roll Call 549) HR 2617 A Lame-Duck Budget With Record Non-Defense Spending Increases.**

This is the appropriations bill for the entire \$1.7 Trillion federal budget for Fiscal Year 2023, and it sets overall spending limits by agency or program. This new budget includes nearly \$800 billion in non-defense funding, a 9.3% increase—\$68 billion—over Fiscal Year 2022. This represents the highest level of non-defense funding ever. Passed only 3 days after being introduced, CPAC vehemently opposes this method of passing the budget, including allowing Democrat’s to pass the first-ever lame-duck omnibus before the new majority takes power, and opposed this bill. The House passed the bill on December 23, 2022 by a vote of 225-201 and the bill later became law.
