#### <u>COMPLAINT FOR DECLARATORY JUDGMENT AND APPLICATION FOR</u> <u>WRIT OF MANDAMUS AND INJUNCTIVE RELIEF</u>

#### **INTRODUCTION**

1. Fulton County has more people registered to vote than there are votingage residents in Fulton County. By any measure, Fulton County's voter registration lists evince problems. By the measure of state and federal law, Fulton County's 113% registration rate is evidence that it is "not making a reasonable effort to conduct a voter list maintenance program in accordance" with the law. *Jud. Watch, Inc. v. Griswold*, 554 F. Supp. 3d 1091, 1107 (D. Colo. 2021).

2. To help bring Fulton County's voter registration lists into compliance with the law, Jason Frazier used his expertise in engineering and data analysis to identify registration errors and bring them to the county's attention. Both federal and state law permit private citizens to bring such challenges. Given Frazier's relevant experience and demonstrated commitment to preserving the integrity of Georgia's elections, the Fulton County Republican Party recognized that he is uniquely suited to help the county's election process. As a result, they nominated him to serve as a member of the Fulton County Board of Elections and Registration.

3. In a cynical act of partisanship, the Fulton County Board of Commissioners rejected the nomination. They did so *because* Frazier had sought to compel Fulton County to clean up its voter rolls. Frazier's efforts to clean up the voter rolls are endorsed by federal and state law. But instead of commending Frazier for his efforts, the Board of Commissioners punished him.

4. Worse still, the Board of Commissioners violated state law in rejecting Frazier's nomination. Section 14-33 of the Fulton County Code states that the Board of Commissioners "shall" appoint two members each from the two major political parties. The Fulton County Republican Party nominated Jason Frazier and Mike Heekin to serve on the Board of Elections. The Board of Commissioners rejected Frazier's nomination even though the law requires that it approve the political parties' chosen nominees. In rejecting Frazier's nomination, the Board of Commissioners violated Georgia law.

#### JURISDICTION

5. This Court has jurisdiction to grant mandamus relief under O.C.G.A. § 9-6-20.

6. This Court is authorized to grant a declaratory judgment under O.C.G.A. § 9-4-2.

7. All of the acts alleged in this complaint were done by Defendants within this judicial district and under the color of Georgia law.

#### PARTIES

8. Plaintiff Fulton County Republican Party is a political party in Fulton County, Georgia as defined by O.C.G.A. § 21-2-2(25) and is authorized under Fulton County Code § 14-33 to nominate candidates to serve on the Fulton County Board of Elections and Registration.

9. Defendant Fulton County Board of Commissioners is a political subdivision of the State of Georgia and is responsible for the policies, practices, customs, and regulations of the Fulton County government, including the Fulton County Board of Elections and Registration. The Board of Commissioners and its members can be served at 141 Pryor Street, SW, Tenth Floor, Atlanta, Georgia 30303.

10. Defendants Robb Pitts, Bridget Thorne, Bob Ellis, Dana Barrett, Natalie Hall, Marvin S. Arrington, Jr., and Khadijah Abdur-Rahman are members of the Fulton County Board of Commissioners. They are sued in their official capacities and can be served in their official capacities at 141 Pryor Street, SW, Tenth Floor, Atlanta, Georgia 30303.

#### BACKGROUND

11. Fulton County has 862,182 registered voters, according to the most recent reports from the Georgia Secretary of State in February 2023.<sup>1</sup>

12. Fulton County has a citizen voting-age population of 758,910, according to the most recent census data.<sup>2</sup>

13. The number of registered voters in Fulton County currently exceeds by more than 100,000 the number of Fulton County residents who are eligible to vote.

14. According to the U.S. Census Bureau, 63.2% of the citizen voting-age population was registered nationwide in the November 2022 election.<sup>3</sup>

15. Compared to the 63.2% national voter registration rate, Fulton County's voter registration rate of 113% is impossibly high.

16. The National Voter Registration Act (NVRA) requires states to maintain accurate voter registration records. Congress enacted the NVRA "to protect the integrity of the electoral process," in part by "ensur[ing] that accurate and current voter registration rolls are maintained." 52 U.S.C. § 20501(b). The NVRA obligates states to "conduct a general program that makes a reasonable effort to remove the names of ineligible voters from the official lists of eligible voters" due to death or change of residence. *Id.* § 20507(a)(4). "[F]ederal law makes this removal mandatory." *Husted v. A. Philip Randolph Inst.*, 138 S. Ct. 1833, 1842 (2018).

17. Fulton County's 113% registration rate leads to but one conclusion: for years, Fulton County has violated federal and state law by failing to maintain accurate voter rolls.

18. In response to failures by counties such as Fulton to remove ineligible voters from their registration lists, the Georgia Legislature created a private right of action allowing "[a]ny elector of the county or municipality [to] challenge the right of any other elector of the county or municipality, whose name appears on the list of electors, to vote in an election." O.G.C.A. § 21-2-230(a). The NVRA creates a similar private right of action to enforce violations of federal voter-registration law. *See* 52 U.S.C. § 20510(b).

19. Jason Frazier, an engineer with experience analyzing large data sets, detected thousands of inaccuracies in Fulton County's voter registration lists. Consistent with federal and state law, he filed challenges to correct Fulton County's voter rolls.

20. The Fulton County Board of Elections and Registration oversees the conduct of election and the registration of voters and absentee balloting procedures. O.G.C.A § 21-2-40; Fulton Cnty. Code § 14-32.

21. The Fulton County Code mandates that five members "shall be appointed" to the Board of Elections according to the procedures described in Fulton County Code § 14-33.

22. The Fulton County Board of Commissioners is the "governing authority of Fulton County" responsible for appointing members of the Board of Elections. Fulton Cnty. Code § 14-33.

23. Under the mandatory appointment procedures, two members "shall be appointed" by the Board of Commissioners "from nominations made by the

chairperson of the county executive committee of the political party whose candidates at the last preceding regular general election held for the election of all members of the General Assembly received the largest number of votes in this state for members of the General Assembly." Fulton Cnty. Code § 14-33(1). Another two members "shall be appointed" by the Board of Commissioners "from nominations made by the chairperson of the county executive committee of the political party whose candidates ... received the second largest number of such votes." *Id.* § 14-33(2). The fifth member "shall be appointed" by the Board of Commissioners "from nominations made by the Fulton County legislative delegation in the General Assembly." *Id.* § 14-33(3).

24. Stephanie Endres is the chairwoman of the Fulton County Republican Party and has served in that role since March 2023. She is the chairperson of an executive committee of a political party authorized to nominate candidates to the Board of Elections under Fulton County Code § 14-33.

25. Over the course of several weeks, the Fulton County Republican Party received applications and interviewed candidates for its nominees to the Board of Elections. An interview panel handled the application process, interviewed candidates, deliberated, and recommended candidates to the chairwoman. The chairwoman reviewed those recommendations, approved them, and presented them to an executive committee comprised of over seventy members. The executive committee in turn deliberated and approved the nominations of Jason Frazier and Mike Heekin to the Board of Elections. Stephanie Endres then nominated Frazier and Heekin to serve as the two Republican nominees to the Board of Elections.

26. On June 7, 2023, the Board of Commissioners convened to vote on the nominations to the Board of Elections.<sup>4</sup>

27. The Board of Commissioners approved resolutions to appoint the two nominees from the Fulton County Democratic Party to serve on the Board of Elections.<sup>5</sup>

28. The Board of Commissioners approved the resolution to appoint Republican nominee Mike Heekin to serve on the Board of Elections.<sup>6</sup>

29. At the meeting, Commissioner Bob Ellis confirmed with the County Attorney that Jason Frazier meets the qualifications for appointment to the Board of Elections: Frazier is a resident and elector of Fulton County, does not hold elective public office, and is not a candidate for elective public office.<sup>7</sup> See Fulton Cnty. Code §§ 14-33, -34.

30. No Commissioner disputed that Jason Frazier meets the qualifications to sit on Board of Elections under Fulton County Code §§ 14-33, -34.

31. More than forty citizens spoke in support of Jason Frazier's nomination at the meeting.<sup>8</sup>

32. Commissioner Ellis warned that rejecting Frazier's nomination would deviate from the Commission's established practice, violate the statute, and lead to litigation.<sup>9</sup>

33. Nevertheless, by a 3-2 vote, the Board of Commissioners failed the resolution to appoint Jason Frazier to serve on the Board of Elections.<sup>10</sup>

34. In failing to appoint Frazier to the Board of Elections, the Board of Commissioners violated the mandatory appointment procedures in Fulton County Code § 14-34.

35. In voicing her opposition to Jason Frazier's nomination, Commissioner Dana Barrett said that Frazier was not a "good-faith nomination" because of his challenges to Fulton County's failure to maintain its voter rolls.<sup>11</sup>

36. No Commissioner contested that Jason Frazier meets the statutory qualifications to serve on the Board of Elections. *See* Fulton Cnty. Code §§ 14-33, -34. No Commissioner defended Fulton County's poor voter-roll maintenance. And no Commissioner claimed that Frazier lacked authority to challenge Fulton County's registration lists under Georgia law.

37. To the extent the Board of Commissioners had any discretion over its appointments to the Board of Elections, it abused that discretion by rejecting Jason Frazier's nomination.

#### COUNT I Failure to Perform a Legal Duty in Violation of Fulton County Code § 14-33

- 38. Plaintiff repeats and realleges each of their prior allegations.
- 39. Fulton County Code § 14-33 sets the procedures for the appointment of

members of the Fulton County Board of Elections and Registration:

The board shall be composed of five members, each of whom shall be an elector and resident of Fulton County, who shall be appointed in the following manner:

Two members shall be appointed by the governing authority of Fulton County from nominations made by the chairperson of the county executive committee of the political party whose candidates at the last preceding regular general election held for the election of all members of the General Assembly received the largest number of votes in this state for members of the General Assembly;

Two members shall be appointed by the governing authority of Fulton County from nominations made by the chairperson of the county executive committee of the political party whose candidates at the election described in paragraph (1) of this section received the second largest number of such votes; and

One member shall be appointed by the governing authority of Fulton County from nominations made by the Fulton County legislative delegation in the General Assembly, which member shall be designated permanent chairperson of the board. The Fulton County legislative delegation shall be composed of all senators and representatives in the General Assembly whose districts are wholly or partially in Fulton County.

Fulton Cnty. Code § 14-33.

40. "Shall' is generally construed as a word of command." Mead v. Sheffield,

601 S.E.2d 99, 100 (Ga. 2004). "The import of the language is mandatory," and it

"precludes any discretion on the part of the officer" acting under the statute. *State v.* 

Collier, 612 S.E.2d 281, 283 (Ga. 2005).

41. Georgia law requires that two members "shall be appointed" from the nominations put forward by the Fulton County Republican Party. Fulton Cnty. Code § 14-33.

42. Stephanie Endres, as the chairwoman of the Fulton County Republican Party, duly nominated Jason Frazier and Mike Heekin to serve as the two Republican nominees to the Board of Elections.

43. By rejecting the nomination of Jason Frazier, the Fulton County Board of Commissioners violated its mandatory duty under Fulton County Code § 14-33 to appoint the two members nominated by the Fulton County Republican Party.

#### COUNT II Abuse of Discretion in Violation of Fulton County Code § 14-33

44. Plaintiff repeats and realleges each of their prior allegations.

45. As an elector and Fulton County resident who is not a candidate for political office, Jason Frazier is qualified to sit on the Fulton County Board of Elections and Registration. *See* Fulton Cnty. Code §§ 14-33, -34.

46. To the extent the Board of Commissioners has discretion to appoint members to the Fulton County Board of Elections and Registration, the Board of Commissioners' rejection of Jason Frazier was arbitrary, capricious, unreasonable, and a gross abuse of discretion.

#### COUNT III <u>Violation of Article I, § 4 and Article 2, § 1 of the U.S. Constitution</u>

47. Plaintiff repeats and realleges each of their prior allegations.

48. The Elections Clause of the U.S. Constitution provides that the "Times, Places and Manner of holding Elections for Senators and Representatives, shall be

prescribed in each State by the Legislature thereof." U.S. Const. art. I, § 4. Similarly, the Electors Clause provides that "[e]ach State shall appoint, such Manner as the Legislature thereof may direct, a Number of Electors" to elect the President of the United States. U.S. Const. art. II, § 1.

49. The Georgia Legislature enacted the mandatory procedures governing appointment of the Fulton County Board of Elections and Registration. *See* Act of Feb. 10, 1989, No. 250, 1989 Ga. Laws 4,577, *codified as amended* at Fulton Cnty. Code §§ 14-31 to -44; Act of Feb. 10, 2013, No. 322, 2013 Ga. Laws 4,503.

50. The mandatory procedures codified at Fulton County Code §§ 14-31 to -44 govern the "Manner of holding Elections for Senators and Representatives," U.S. Const. art. I, § 4, and the "Manner" of choosing presidential electors, U.S. Const. art. II, § 1.

51. The Fulton County Board of Commissioners is not the "Legislature" of Georgia. U.S. Const. art. I, § 4; U.S. Const. art. II, § 1.

52. By violating a mandatory requirement imposed by Georgia Legislature to appoint two members from the Fulton County Republican Party, the Fulton County Board of Commissioners violated the Elections Clause and the Electors Clause of the U.S. Constitution. *See* U.S. Const. art. I, § 4; U.S. Const. art. II, § 1.

#### COUNT IV Declaratory Relief Under O.G.C.A § 9-4-1

53. Plaintiff repeats and realleges each of their prior allegations.

54. In rejecting Jason Frazier's nomination to the Fulton County Board of Elections and Registration, Defendants violated Fulton County Code § 14-33, U.S. Const. art. I, § 4, and U.S. Const. art. II, § 1.

55. There is an actual and justiciable controversy between Plaintiff and Defendants about the parties' legal rights and obligations that can be remedied only by a declaration of this Court under O.C.G.A. § 9-4-1.

56. Plaintiff has met the requirements for, and are entitled to, prospective declaratory relief that Defendants violated state and federal law.

#### COUNT V <u>Mandamus Relief Under O.G.C.A § 9-6-20</u>

57. Plaintiff repeats and realleges each of their prior allegations.

58. "Mandamus will issue against a public official only where the petitioner has demonstrated a clear legal right to relief or a gross abuse of discretion." *Burke Cnty. v. Askin*, 732 S.E.2d 416, 419 (2012) (citation omitted).

59. In rejecting the nomination of Jason Frazier, the Fulton County Board of Commissioners violated the clear legal right of the Fulton County Republican Party to its chosen nominee.

60. To the extent the Board of Commissioners has discretion to appoint members to the Fulton County Board of Elections and Registration, the Board of Commissioners' rejection of Jason Frazier was arbitrary, capricious, unreasonable, and a gross abuse of discretion.

61. Plaintiff has a clear legal right to relief for which there is no adequate remedy at law.

#### COUNT VI Injunctive Relief under O.C.G.A. § 9-4-3

62. Plaintiff repeats and realleges each of its prior allegations.

63. Plaintiff seeks to maintain the status quo by restraining the Board of Commissioners from filling the vacancy on the Board of Elections pending this Court's consideration of the within request for relief.

64. "The purpose of a temporary restraining order or interlocutory injunction is to preserve the status quo while a case is pending." Slone v. Myers, 288 Ga. App. 8, 14, 653 S.E.2d 323 (2007), overruled on different grounds, Reeves v. Upson Med Ctr., 315 Ga. App. 582, 726 S.E.2d 544 (2012). When deciding whether to issue a temporary restraining order and/or interlocutory injunction, the trial court should consider whether: (1) there is a substantial threat that the moving party will suffer irreparable injury if the injunction is not granted; (2) the threatened injury to the moving party outweighs the threatened harm that the injunction may do to the party being enjoined; (3) there is a substantial likelihood that the moving party will prevail on the merits of her claims at trial; and (4) granting the [relief] will not disserve the public interest. Bishop v. Patton, 288 Ga. 600, 604, 706 S.E.2d 634 (2011) ("The first factor ... is the most important one, given that the main purpose of an interlocutory injunction is to preserve the status quo temporarily to allow the parties and the court time to try the case in an orderly manner"), disapproved upon other grounds, SRB Inv. Servs. LLLP v. BB&T, 289 Ga. 1,5 n.7, 709 S.E.2d 267 (2011" ("To the extent that our opinion in Bishop ... may

be read as requiring the moving party to prove all four ... factors to obtain an interlocutory injunction, it is hereby disapproved").

65. All four of these factors are met, and Plaintiff is entitled to a temporary restraining order and interlocutory injunction.

#### A. There is a Substantial Threat that Plaintiff Will Suffer Irreparable

#### Injury if Defendants are Not Restrained and Enjoined.

Absent temporary restraint, the vacancy on the Board of Elections is subject to being filled by Board of Commissioners appointment which could occur as early as the next meeting on Wednesday, July 12, 2023.<sup>12</sup> Once the vacancy is filled, Plaintiff will permanently lose its right to the appointment of its nominee Jason Frazier, a statutory right, which will be filled by another person not of Plaintiff's choosing.

#### B. The Balance of the Equities Favor Plaintiff.

Issuing a temporary restraining order while the present request is considered does not irreparably harm the Board of Commissioners. A missing member reduces the Board of Elections but does not cause a quorum failure or prevent said Board of Elections from functioning. However, if Defendants exercise their authority under Fulton Code 14-37 to appoint another individual, Plaintiff's right to have Jason Frazier approved for the open board seat is lost as there is no clear path to unwind such an appointment.

C. <u>There is a Substantial Probability that Plaintiff Will Prevail on the</u> Merits.

The likelihood of the plaintiff's ultimate success is not the determinative factor for the purposes of the instant motion. *See Garden Hills Civic Assoc., Inc. v. MARTA*, 273 Ga. 280, 281, 539 S.E.2d 811 (2000" ("[T]]he possibility that a party obtaining a preliminary injunction may not win on the merits does not determine the propriety or validity of a trial court's [decision to grant] a preliminary injunction") (citation and punctuation omitted). However, Plaintiff is very likely to prevail on the merits of his claims. As evidenced by this Petition, supporting affidavit and exhibits attached hereto, Plaintiff has a clear legal right under Section 14-33 of the Fulton County Code to have its nominee Jason Frazier appointed to the Board of Elections and Defendants have no legitimate objection.

D. The Requested Relief Would Not Disserve the Public Interest.

The public interest will be served by assuring that the intention of Section 14-33 is implemented, and Defendants' obvious intention to circumvent that law is thwarted.

**WHEREFORE**, Plaintiff respectfully requests that this Court enter judgment in favor of Plaintiff and against Defendants and provide the following relief:

- A. A Rule Nisi issue commanding Defendants to appear and show cause why the relief demanded herein should not be granted.
- B. A declaratory judgment that Defendants violated Fulton County Code § 14-33, U.S. Const. art. I, § 4, and U.S. Const. art. II, § 1.
- C. A writ of mandamus ordering Defendants to appoint Jason Frazier to the Fulton County Board of Elections and Registration.

- D. Plaintiffs reasonable costs and expenses of this action, including attorneys' fees; and
- E. All other, further relief that Plaintiff may be entitled to.



I am the current Chairwoman for the Fulton County Republican Party and I submit this affidavit in support of the COMPLAINT FOR DECLARATORY JUDGMENT AND APPLICATION FOR WRIT OF MANDAMUS AND INJUNCTIVE RELIEF filed concurrently herewith. 3.

I have personal knowledge concerning the matters discussed herein, and am under no disability that would prevent my testimony.

#### 4.

The facts set forth in the foregoing COMPLAINT FOR DECLARATORY JUDGMENT AND APPLICATION FOR WRIT OF MANDAMUS AND INJUNCTIVE RELIEF are true and correct.

#### 5.

The Fulton County Republican Party is aware of, and intends to exercise its statutory right to be represented on the Fulton County Board of Elections.

6.

As described in the Complaint, the Fulton County Republican Party used a democratic process to identify and nominate its candidates for appointment to the Board of Elections. Consideration was open to any resident of Fulton County submitting an application. An interview panel handled the application process, interviewed candidates, deliberated, and recommended candidates to the chairwoman. The chairwoman reviewed those recommendations, approved them, and presented them to an executive committee comprised of over seventy members. The executive committee in turn deliberated and voted to approve the nominations of Jason Frazier and Mike Heekin to the Board of Elections. The chairwoman then nominated Frazier and Heekin to serve as the two Republican nominees to the Board of Elections.

The nominating process involved the participation of numerous persons and imposed substantial costs in terms of time and effort; and any effort to consider additional candidates as the result of the Fulton County Board of Commissioners' failure to approve Jason Frazier to the Board of Elections would result in substantial and undue hardship on the Fulton County Republican Party.

The Fulton County Republican Party is deeply concerned that the Fulton County Board of Commissioners may now declare a vacancy on the Board of Elections and exercise its authority under Fulton County Rule 14-37 to appoint another individual to the Fulton County Board of Elections, thereby denying the Fulton County Republican Party of its statutory right to have its nominee approved.
