<sup>\*</sup>These numbers do not reflect all people with a sex offense conviction, only those convicted of sexual assault or sexual abuse.

<sup>\*</sup>Numbers provided exclude any juvenile sex offense convictions.

<sup>\*</sup>A person may have additional offenses for their current incarceration that are not a sex offense.

<sup>\*</sup>Regarding "charged", numbers include only finalized conduct reports resulting in a guilty verdict – this mostly closely aligns with what may be considered a criminal charge by the police resulting in action taken by the courts.

<sup>\*</sup>Conduct reports are not available prior to February 2019.

\*A "charge" for sexual assault or sexual abuse while in prison includes a finding of guilt for conduct reports involving either DOC 303.16 Sexual assault or DOC 303.17 Sexual assault-aggravated.

DOC 303.16 Sexual assault. (1) An inmate who does any of the following with another person with force or the threat of force is guilty of sexual assault:

- (a) Has sexual intercourse.
- (b) Has sexual contact.
- (c) Commits an act of sexual gratification.

DOC 303.18 Sexual assault-aggravated. (1) An inmate who does any of the following is guilty of sexual assault-aggravated:

- (a) Causes physical injury as a result of a sexual assault.
- (b) Uses a weapon in the commission of a sexual assault.
- (c) Has sexual contact or sexual intercourse with a person who has not attained the age of 16 years.

Below is a list of statutes included to identify whether someone was convicted of "sexual abuse" or "sexual assault". The overall statute is listed, as well as some sub-statutes, but greater detail beyond that is not provided. Not all of these offenses may be represented in the data; rather, these statutes were the baseline for determining whether a person had any history of a sexual offense (e.g., to create a flag for sex offenses).
